## **INTRODUCTION**

I have the honour to submit my Annual Report to the Oireachtas for the year ended 31 December 2009, in accordance with the provisions of Section 103 of the Patents Act, 1992.

During 2009 the Office continued to focus on implementing elements of our three year Strategy Statement with a view to continuing to improve efficiency and our service to our customers. This included a review of our Application Forms and support documentation, a review of our standard letters and a major review of the processes and procedures in the Office. The result of these reviews will lead to an improved and more efficient service to our customers.

Staff in the Office showed their continued willingness to innovate, improve and embrace change in work practices and technology despite the effects of budgetary cutbacks. I commend all those working in the Patents Office for their commitment to continued improvement during the year.

The Intellectual Property Unit (IPU) of the Department of Enterprise, Trade and Employment has responsibility for intellectual property policy and preparation of legislation in this field. My Office furnishes advice in these matters to the Department, including comments on the impact on its work of proposed legal or regulatory changes. In November 2009, I was given responsibility for the operations of the IPU. This dual responsibility has resulted in bringing the operational and policy functions closer together and has facilitated greater co-ordination in the delivery of IP services in the State.

My Report is in respect of the execution of my statutory functions under the Patents Act, 1992, the Trade Marks Act, 1996; the Industrial Designs Act, 2001, the Statutory Rules and Regulations made under these Acts; and the European Communities (Supplementary Protection Certificate) Regulations.

Decisions under these Acts, Rules and Regulations rest with me in my statutory capacity, subject to certain rights of appeal to the High Court. I also have certain statutory functions under the Copyright and Related Rights Act, 2000 largely concerned with dispute resolution, copyright licensing schemes and with registration of licensing bodies. In addition, my Office makes information available on Industrial and Intellectual Property.

In my report, unless the context otherwise indicates, a reference to the "1927 Act" means the Industrial and Commercial Property (Protection) Act 1927, to the "1963 Act" means the Trade Marks Act, 1963, to the "1964 Act" means the Patents Act, 1964, to the "1992 Act" the Patents Act, 1992 (as amended), to the "1996 Act" the Trade Marks Act, 1996 and a reference to the "2001 Act" means the Industrial Designs Act, 2001. The report provides information on the operating and financial results for my Office for 2009. It includes key performance information related to the services provided and statistical information on IP of interest to domestic and international organizations.

**GENERAL**

The Patents Office is responsible for the granting and registration of intellectual property rights in Ireland. Innovation and creativity which are captured in intellectual property are important elements in gaining a competitive edge in the marketplace and for many business ventures, intellectual property is one of their most important assets. Through the provision and administration of the patents, trademarks and design registration system, the Office assists Irish business, industry and individual entrepreneurs to optimise the economic potential of their intellectual property.

This annual report is structured around the six strategic objectives set out in the Office's Statement of Strategy for the period 2008 to 2010 which are seen as central to the operational efficiency of the Office. The aim of this strategy, which is delivered through annual business plans, is to facilitate an environment in Ireland where individuals are able to achieve their rights and entitlements under the various pieces of IP legislation to the greatest extent possible and according to their needs.

**Objective (1)**

**To grant and maintain patents, to register and maintain trademarks and designs and to carry out the statutory functions under the Copyright legislation, transparently and accountably, based on international best practice.**

Business volumes continued to fluctuate in 2009, though with an overall downward trend becoming more evident. The year 2008 was the first time the Office has received more than 1000 patent applications since the year 2001. However, in 2009 patent filings fell by 4.5%; down to 961 from the high of 1,007 achieved in 2008. The total number of long term patent applications received during 2009 was down 8.9% on 2008 from 457 to 415. Short term applications received in 2009 were down 0.73% on 2008 from 550 to 546.

Applications for Supplementary Protection Certificates increased by over 14% from 35 in 2008 to 41 in 2009 – an indication of the continuing importance of patent protection for medicinal products for the pharmaceutical industry.

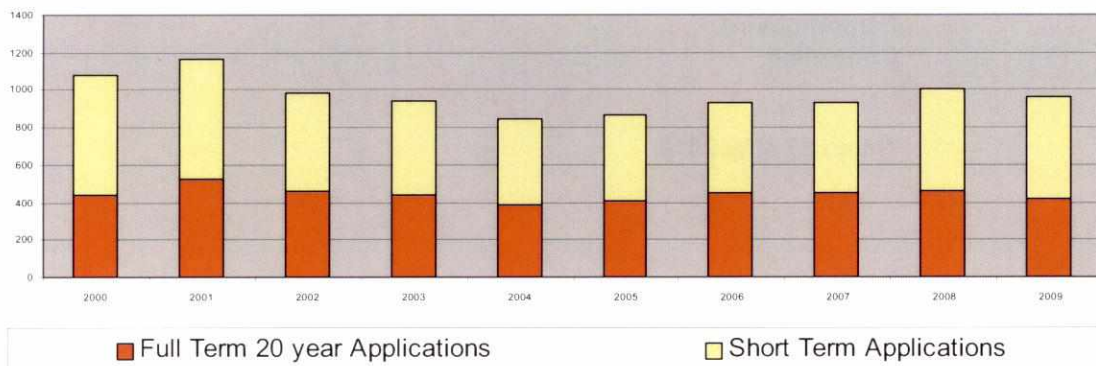
Applications for the registration of industrial designs, which had seen a steady decline since 2003 when the Community Design registration system came into being, had increased in 2008 but fell by 36% in 2009 from 69 to 44.

Business volumes in trade marks continued a decline which had begun in 2008. The total number of National trade mark applications received in 2009 was down 13.3% on 2008 from 2,690 to 2,339. International applications for marks seeking protection in Ireland were down 26.5% by comparison to 2008 from 2,506 to 1,871.

The data indicates that the filing of new patent, design and trade mark applications is continuing to be affected by the recession. This is much more evident in the case of National and International trade marks and does suggest a continuing lack of business confidence with little or no new products or services (for which TM protection would be desirable) coming on stream.

While patent applications have been less affected and short term applications hardly at all, a contraction is still evident bearing in mind that patent applications had been showing a modest growth (an average increase of 4.5%) each year since 2004.

Performance was generally satisfactory overall. However, performance against several targets mainly associated with the initial processing stages of applications which had tended to fluctuate in previous years, showed an improvement over the first half of the year but dropped in the latter half of 2009. This fluctuation in performance can, for the most part, be attributed to staff changes and reduced staff numbers in the area responsible for manual key in of application data. Increased use of automated processing has allowed a growing number of targets to be fully met and it is intended that a planned increase automation at the initial application processing stage e.g. resulting from the introduction of online filing of trade mark applications, will lead to improved performance levels in the future.

#### **Objective (2)**

**To recognise staff as a key asset and to have a well-trained, flexible and customer-focused team.**

As of 31 December 2009, the Office operated with 60 authorised posts a reduction of 3 on 2008, When career breaks, worksharing and other family friendly working arrangements are taken into account, this equates to a staffing level of 53 full time equivalents during 2009. The day-to-day willingness of staff, at all levels, to initiate change and to continue to improve work practices has allowed the Office to be a leaner and more efficient working unit which has already risen to the challenge of meeting the demand for high levels of public services with less resources.

During 2009, staff development continued with the aim of ensuring that all staff, including new staff obtained appropriate training in the skills and competencies required to undertake their job to the highest standard. In accordance with the Performance Management Development System (PMDS) operated in the Office, a development plan for training was drafted which took into account the various training needs which staff had identified in their personal development plans. Outside of on-the-job training, staff in my Office undertook a total of 96.5 training days during 2009. Training was provided in areas such as business process re-engineering, staff management and leadership skills, information and communication technology skills, communications and assertiveness skills and in the use of the ESP@CENET patent search system.

#### **Objective (3)**

**To continuously review our processes, procedures and computer systems to improve our service to our customers.**

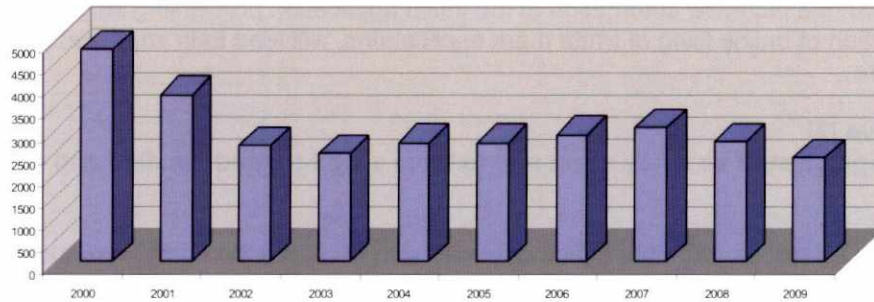
The Government's decision to substantially cut expenditure on public services in 2009 impacted on the Office's allocation for ICT development. Nonetheless, the Office sought to maximise the financial resources allocated to it in prioritising and progressing those developments which offered the most in terms of improved efficiency. Seven substantive enhancements to the PTOLEMY Administration system were developed and implemented in 2009 all of which were aimed at improving operational efficiency.

In an effort to improve the quality of its communication with its customers the Office reviewed and redeveloped the content and support documentation of its Applications Forms. It reviewed the style and content of its standard letters and devised an improved the approach to letter writing. It also redeveloped areas of its website to incorporate the new forms and support documentation.

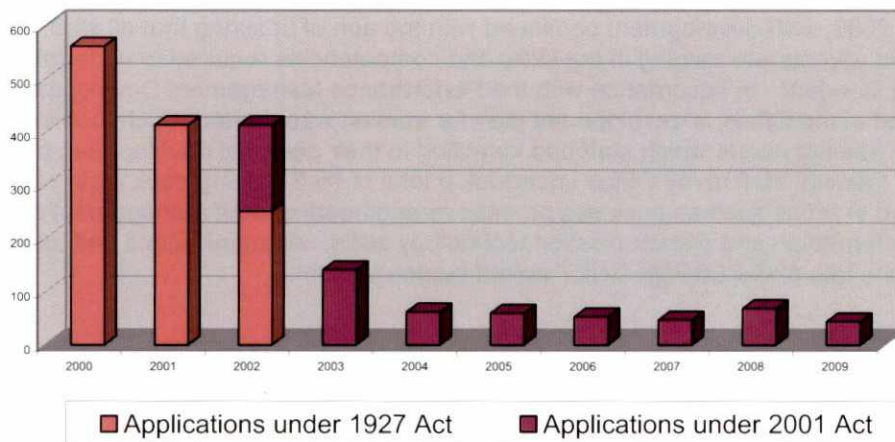
In addition, an extensive review of the administrative procedures and processes in the Office was undertaken with a view to simplification of same and, where possible, taking advantage of automation and electronic processing to improve efficiency. The in-house process review identified 61 improvements of which 40 were immediately implemented. The balance, most of which required some adaptation of the computerised Administration system, were prioritised and will be implemented as and when funds become available.

Computerising simple and frequently used services and introducing email-based services can improve access to information for the public, enable self-service, reduce processing times, improve productivity and reduce costs. In its contribution to these objectives and the promotion of e-government the Office has sought to use technology to deliver services electronically. To this end development work commenced in 2009 to facilitate the issuing of thousands of renewal reminders and overdue reminders electronically by Email instead of by post. This project will be rolled out early in 2010 and is the first step in a process which will see the majority of the Office's incoming

Declines in business volumes and in particular decisions by business not to maintain their IP rights in force, impacted on the Office's fee income. The bulk of the Office's fee income comes from renewal fees and declines were evident during the period January to September 2009. While there was some improvement in the last quarter, renewal income from National trade marks for 2009 was down by 1.4% on 2008. Fees in respect of International trade marks seeking protection in Ireland were down by over 17%. National Patent renewal fee income was down by over 14% on 2008. The decline in renewal fee income is perhaps attributable to business closures and a decline in entrepreneurial activity, with financial constraints preventing the renewal of a trade mark or the ceasing of the manufacture of a patented product.

Somewhat less affected by the recession has been renewal fee income from European Patents (up 3% on 2008). This has helped offset the drop in other renewal fee income and resulted in the Office's outturn for receipts being in line with that estimated.

More detailed information can be found in the Business Statistics and Financial Information sections of the Report.

The development of a strong customer service ethos in the carrying out of the Controller's statutory functions was an integral part of the Office's Customer Service Action Plan for the period 2006 to 2009. The Plan sets out a series of customer service targets against which performance is monitored during the year. The level of performance against specific customer service targets achieved during 2009 is reported on in some detail later in this report.

and outgoing correspondence being dealt with electronically by Email rather than on paper and by post.

During 2009 the Office developed a procedure whereby thousands of paper files are no longer created for granted European Patents designating and validated in Ireland each year which are entered on the Irish Register. All information regarding these European Patents is now stored electronically and any paper correspondence received is scanned and associated with the relevant electronic file. This procedure became operational on 1 January 2010 and facilitates ease of access to the files for staff, has reduced processing time and will result in a considerable saving in storage space.

The implementation of a project to facilitate online access to published Irish patent specifications was deferred again due to budgetary constraints.

#### **Objective (4)**

##### **To increase awareness of intellectual property.**

During 2009 the Office's information delivery strategy, in addition to outreach activities, focused on further enhancement of the data in the Office's website, a review of some of the the Office's publications, preparation of consolidate versions of the Patents Acts and Rules, the establishment of an FAQ database to assist staff in dealing with queries form the public. Work continued on updating and re-compiling an index of the contents of the Patents Office Library.

In line with its strategic objective to increase awareness of IP among the public, the Office continued with its outreach efforts directed particularly at the small business start up sector and students. The small business sector has been identified as key to fostering future growth and competition in the economy.

During 2009, the Office had a presence at a range of public events where we have availed of opportunities to disseminate information and raise awareness of the importance of IP and how to protect it. Staff gave talks on IP to participants at "start your own business courses" organised by seven County Enterprise Boards. Staff also exhibited and provided advice at 3 Business Advice shows (sponsored by the Bank of Ireland and County Enterprise Boards) in Galway, DunLaoghaire and Cork and at 7 Enterprise Exhibitions covering Counties Wicklow, Donegal, Clare, Limerick, Tipperary, Dublin and Kilkenny. In addition, IP seminars were held at Carlow and Limerick Institutes of Technology.

To mark World Intellectual Property Day the Patents Office ran a series of events during an open day at the office on 27 April 2009. Talks on IP and commercialisation were given to a group of persons from the small business sector and persons interested in business start-ups by a Patents Office staff member and a representative from Enterprise Ireland. The open day culminated in the award of prizes to participants in the Junior Inventor 2009 competition (aimed at primary school pupils), which had as its theme "Green innovation as the key to a secure future". The idea of this competition is to encourage awareness of primary school children of innovation and inventions and to start developing an interest in science and engineering. Over 200 persons (pupils, teachers, parents and business interests) attended events during the open day. The first prize-winner who was from Rathfarnham National school was interviewed for RTE's Six One news programme. The Patents Office succeeded in generating considerable media interest in the Junior Inventor Competition with articles appearing in all national newspapers, regional and local newspapers and free sheets in the Dublin and Wicklow areas. It is intended to run the Business Seminar and the Junior Inventor Competition again in 2010.

As in previous years the Office was an exhibitor at the BT Young Scientist & Technology Exhibition. The Office sponsors a prize at the Exhibition which was won by Liam McCarthy and John O'Callaghan from Kinsale in Cork for their invention of a cheap and efficient method of detecting infection in cows milk using ordinary washing-up liquid. The students were overall winners at the BT Young Scientist & Technology Exhibition and went on to represent Ireland in the European Young Scientist competition in Paris in September winning one of the top three prizes.



**Objective (5)**

**To continue to foster good relations with the Department and contribute to the development of legislation relating to Intellectual Property.**

During 2009, the Office made proposals and provided input to the Intellectual Property unit of the Department of Enterprise, Trade and Employment in relation to the drafting of the following pieces of legislation:

- Draft Trade Mark Amendment Rules
- Draft Fees Rules
- Draft Design Amendment Rules
- Patents (Amendment) Rules, 2009
- Copyright and Related Rights (Proceedings Before the Controller) Rules, 2009

In addition, the Office provided further observations regarding:

- compliance with the provisions of the Services Directive insofar as it applies to the regulated professions of patent and trade mark agent,
- the consultation document on the London Agreement, and
- the consultation document on possible changes to Irish trade mark procedures regarding examination of Trade Mark applications on Relative Grounds.

My appointment as head of the Intellectual Property Unit in the Department in addition to my role as head of the Patents Office has facilitated closer co-operation and contact between the Office and the IPU which has facilitated better co-ordination and better consideration of policy initiatives as well as the exchange of information on international developments.

**Objective (6)**

**To represent Ireland at international fora.**

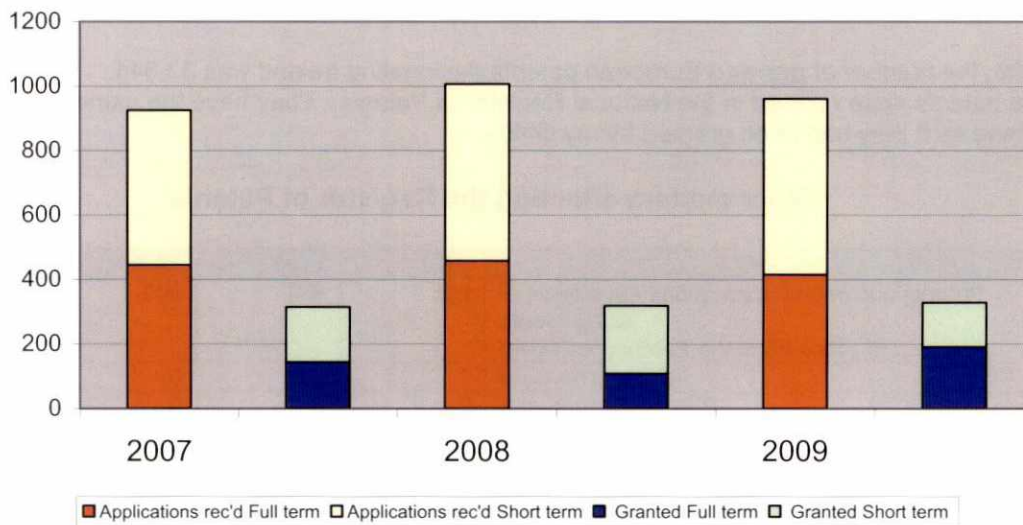
During 2009, staff from the Office attended meetings with the EU Commission, WIPO, the Administrative Council of the EPO and several of its Committees, the Administrative Board of OHIM and several of its various technical and liaison committees which dealt with various issues concerning intellectual property. Attendance at these meetings provides excellent opportunities to gather intelligence on best practices at the international level, to build understanding and to facilitate collaboration with other national and international industrial property offices. It also facilitates one-to-one dialogue with staff of the EPO and OHIM in regard to advancing cooperation programmes between those organisations and the Office to further enhance or develop the Office's services to its customers.

**Note on Patent Classification**

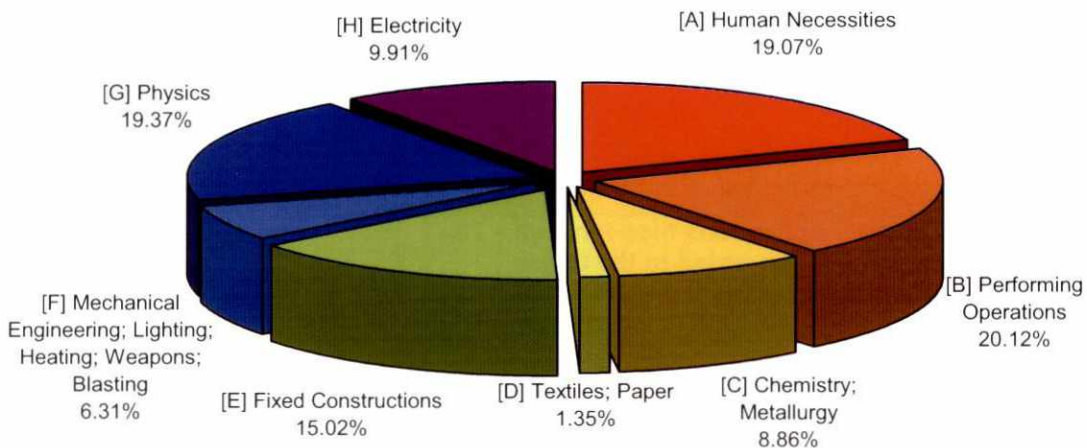
Patents are given classifications based on their technical content. Such classification allows retrieval of patents according to the nature of the inventions revealed therein. The International Patent Classification (IPC) is the standard system for patent classification. It consists of about 70,000 classification symbols divided between 8 basic sections (A to H), relating to different basic kinds of technology. In 2009, it was in its 9th edition (Int. Cl. (2009)). A classification code is given for each inventive thing in a patent. A patent may contain two or more inventions as long as they are sufficiently related; for instance, a new chemical compound and its use as a medicine or herbicide, or a new laser and its use in eye surgery or data readers. Accordingly, a patent may need a number of classification symbols to cover the whole of its content.

The accompanying table and graph collates the total number of classifications allocated to granted patents in 2009. Each individual classification represents an inventive thing disclosed in a patent, so this is akin to a tally of inventiveness. The classifications are grouped by IPC section.

**Granted Patent Classifications by IPC Section in 2009**



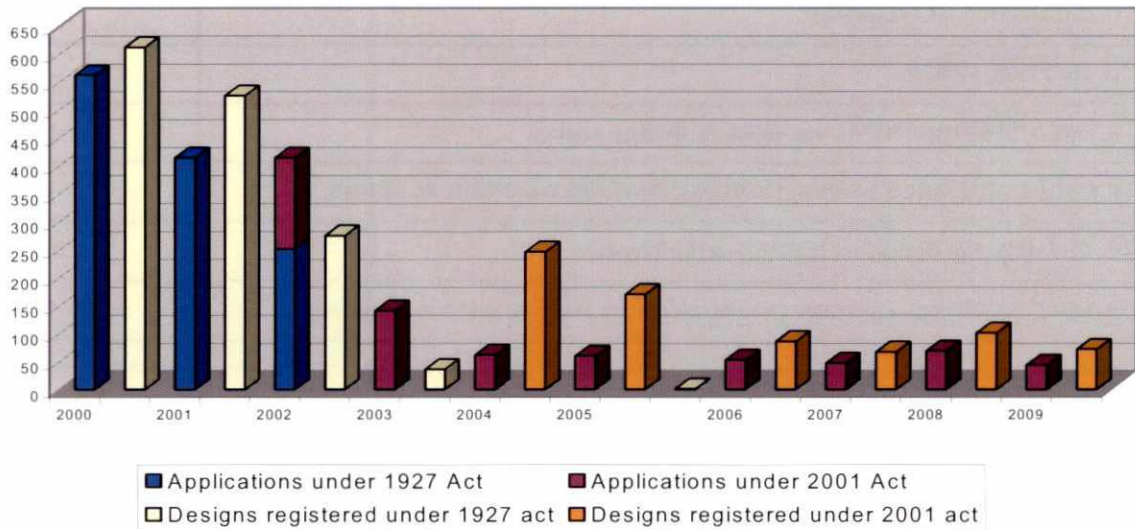

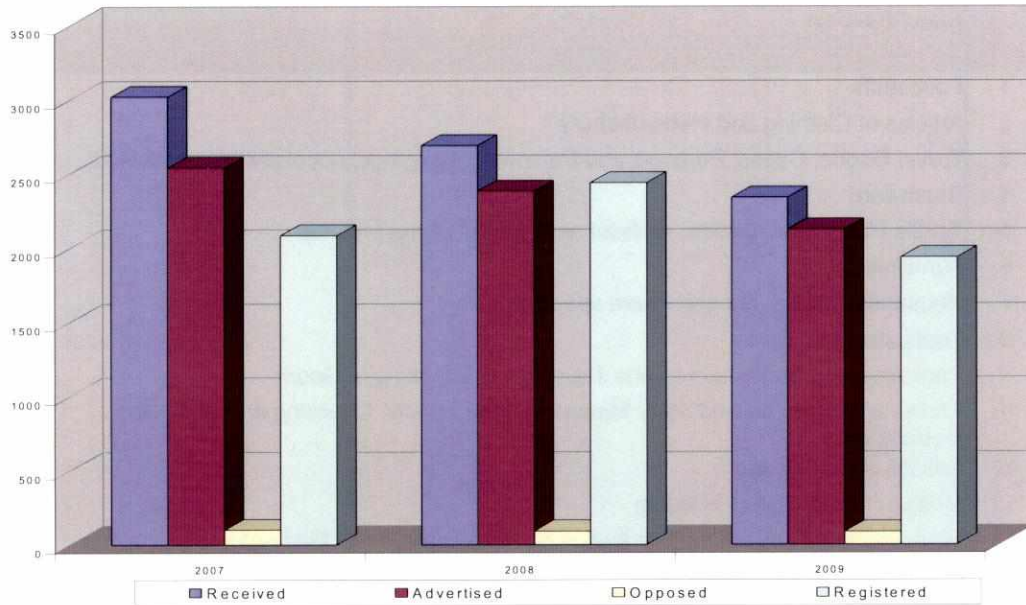
A multilateral treaty called "the Locarno Agreement Establishing an International Classification for Industrial Designs" established a classification system for industrial designs. The Locarno Classification comprises a list of 32 classes of goods in which industrial designs may be incorporated. The classification is administered by the World Intellectual Property Organisation (WIPO) and the current (ninth) edition has been in force since January 1, 2009.

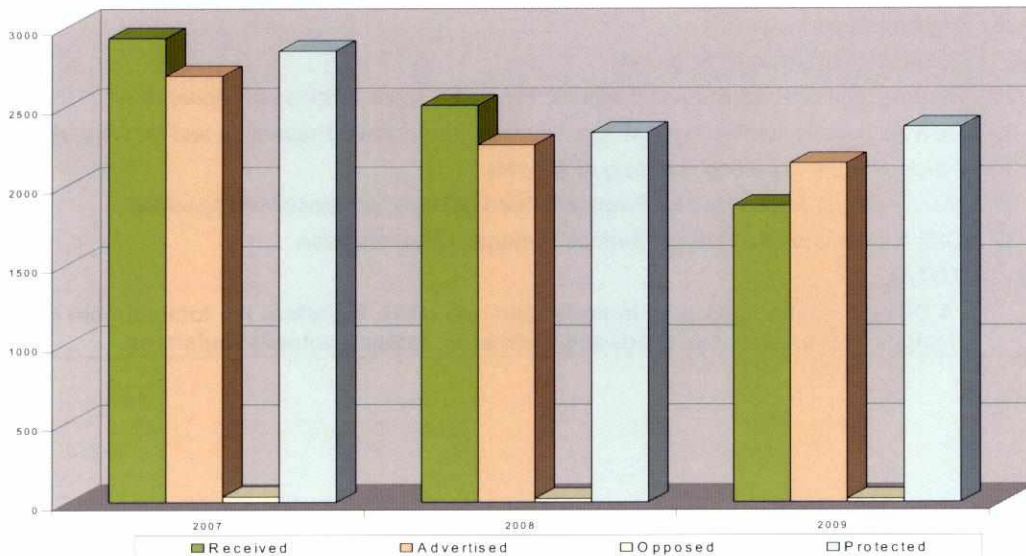

**INTERNATIONAL CLASSIFICATION OF GOODS AND SERVICES INTO WHICH MARKS REGISTERED IN 2009 FALL**

A multilateral treaty called the "Nice Agreement Concerning the International Classification of Goods and Services for the Purposes of the Registration of Marks" established a classification system for trade marks. The Nice Classification comprises 45 class headings which describe in very broad terms the nature of the goods or services contained in each of the 34 classes of goods and 11 classes of services into which trade marks may fall. The classification is administered by the World Intellectual Property Organisation (WIPO) and the current (ninth) edition has been in force since January 1, 2007.

## **COPYRIGHT**

### **References to the Controller under the Copyright & Related Rights Act, 2000**

Under Section 38 of the Act, disputes between persons playing sound recordings in public and the owner of the copyright subsisting in the recordings, regarding the equitable remuneration payable to the copyright owner, may be referred to the Controller for determination.

Under Section 152 of the Act, where a dispute arises between the operator of a licensing scheme concerned with copyright works and a person, claiming that he or she requires a licence under the scheme, that person or operator may refer the scheme to the Controller for determination.

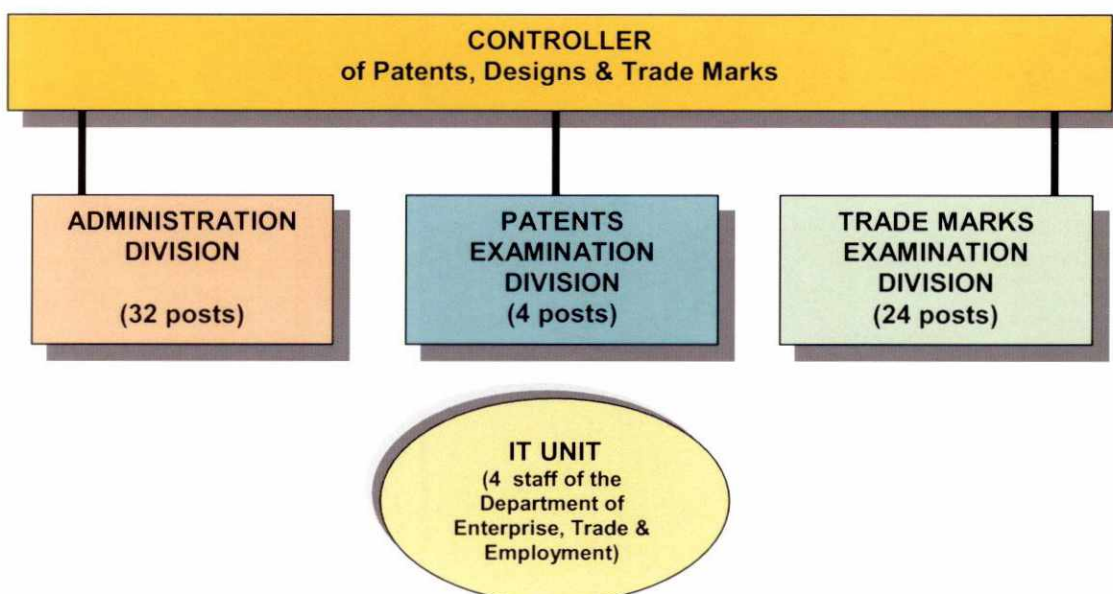

## **LEGISLATION**

The Intellectual Property Unit of the Department of Enterprise, Trade & Employment has responsibility for policy and the preparation of legislation relating to intellectual property.

### **Legislation enacted in 2009**

#### **PATENTS (AMENDMENT) RULES 2009 (S.I. No. 194 of 2009)**

These amendments to the Patent Rules 1992 arise from changes to primary legislation mainly related to the enactment of the Patents (Amendment) Act, 2006 along with some rules allowing for procedural changes. Certain rule amendments are necessary to allow for the commencement of some sections of the Patents (Amendment) Act 2006, in particular, the provisions relating to the Patent Law Treaty.

#### **PATENTS (AMENDMENT) ACT 2006 (CERTAIN PROVISIONS) (COMMENCEMENT) ORDER 2009 (S.I. No. 196 of 2009)**

This Order appoints 21st May 2009 as the date on which specified provisions of the Patents (Amendment) Act 2006, arising from the commencement of the Patent (Amendment) Rules 2009, come into operation.

#### **COPYRIGHT AND RELATED RIGHTS (PROCEEDINGS BEFORE THE CONTROLLER) RULES 2009 (S.I. No. 20 of 2009)**

These Rules prescribe the procedures to be observed and the fees payable in relation to proceedings before the Controller of Patents, Designs and Trade Marks under the Copyright and Related Rights Act 2000 (No. 28 of 2000).

#### **COPYRIGHT AND RELATED RIGHTS ACT 2000 (NOTICE OF SEIZURE) REGULATIONS 2009 (S.I. No. 440 of 2009)**

These Regulations prescribe the form of the notice, to be given at the time of seizure, to the owner, occupier or person in charge of the place where infringing copies, illicit recordings, protection-defeating devices or articles associated with making infringing copies or illicit recordings, as the case may be, are seized under Section 133 or Section 257 of the Copyright and Related Rights Act 2000.

#### **BROADCASTING ACT 2009 (S.I. No. 18 of 2009)**

Section 183 of this Act amended Section 2 of the Copyright and Related Rights Act 2000 in respect of definitions relating to digital terrestrial retransmission.

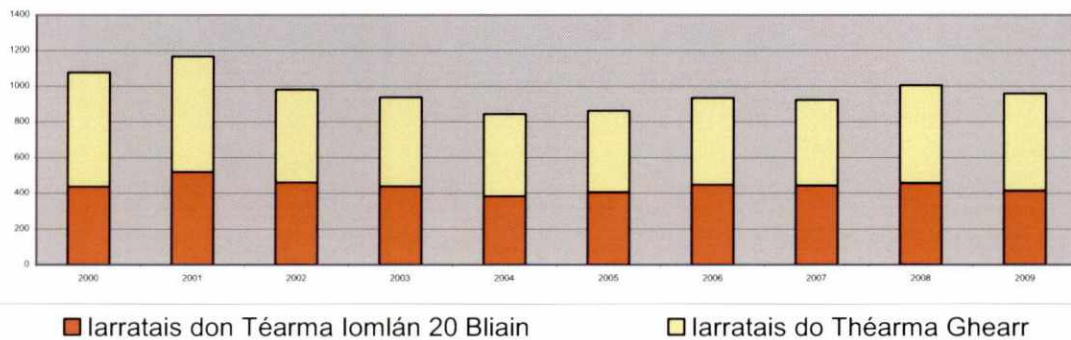

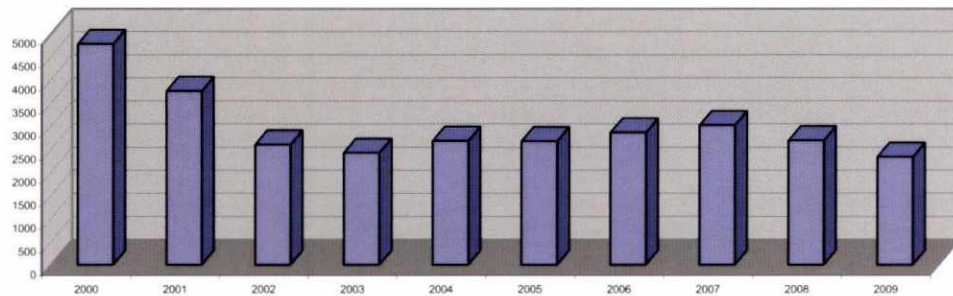

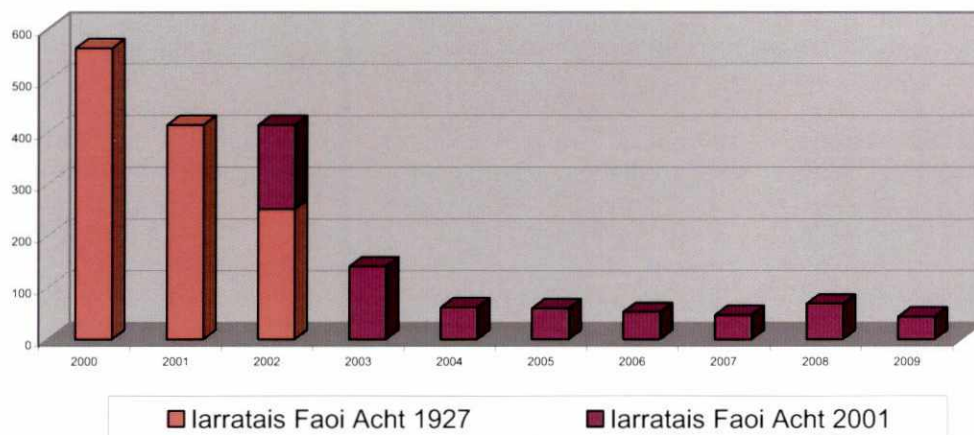
**Iarratais Náisiúnta ar Phaitinní 2000-2009**

Is lú an tionchar a bhí ag an meathlú geilleagrach ar ioncam ó tháillí athnuachana ó Phaitinní Eorpacha (suas 3% ar 2008). Tá seo tar éis cabhrú le fritháireamh a dhéanamh ar ioncam eile ó tháillí athnuachana agus mar thoradh air sin bhí toradh na bhfáltas ag teacht lena raibh measta.

Is féidir faisnéis níos mionsonraithe a fháil sna rannáin ar Staitisticí Gnó agus Faisnéis Airgeadais den Tuarascáil.

Bhí forbairt ar éiteas láidir seirbhíse do chustaiméirí i gcomhlíonadh feidhmeanna reachtúla an Rialtóra ina chuid lárnach de Phlean Gníomhaíochta um Sheirbhísí do Chustaiméirí na hOifige don tréimhse 2006 go dtí 2009. Leagann an Plean amach sraith de spriocanna seirbhíse do chustaiméirí lena ndéantar monatóireacht ar fheidhmíocht i rith na bliana.

I rith 2009, leanadh le forbairt na foirne d'fhonn a chinntiú gur cuireadh an oiliúint chuí ar an bhfoireann go léir, ar a n-áirítear an fhoireann nua, ar na scileanna agus na hinniúlachtaí atá ag teastáil lena bpost a dhéanamh ar an gcaighdeán is airde. De réir an Chóras Bainistíochta agus Forbartha Feidhmíochta (CBFF) atá ag feidhmiú san Oifig, déanadh dréachtú ar phlean forbartha d'oiliúint a chuir na riachtanais éagsúla oiliúna, a bhí aitheanta ag an bhfoireann ina bpleananna forbartha pearsanta, san áireamh. ### **Cuspóir (3)**

**Athbhreithniú leanúnach a dhéanamh ar ár bpróiseas, ár nósanna imeachta agus ár gcóras ríomhaireachta le feabhas a chur ar ár seirbhís dár gcustaiméirí.**

Bhí tionchar ag cinneadh an Rialtais in 2009 caiteachas ar sheirbhísí poiblí a ghearradh go mór ar leithdháileadh na hOifige d'fhorbairt TFC. Mar sin féin, rinne an Oifig iarracht ar uasmhéadú a dhéanamh ar na hacmhainní airgeadais a leithdháileadh uirthi le tosaíocht a dhéanamh ar na forbairtí sin a raibh an chuid ba mhó ag baint leo i dtéarmaí feabhais ar éifeacht, agus iad a chur chun cinn. Déanadh forbairt agus cur i bhfeidhm ar sheacht bhfeabhsúchán substaintiúil sa chóras Riaracháin PTOLEMY in 2009 a raibh gach ceann acu dírithe ar fheabhas a chur ar éifeachtúlacht oibríochtúil.

In iarracht ar fheabhas a chur ar cháilíocht a cuid cumarsáide lena custaiméirí, rinne an Oifig athbhreithniú agus athfhorbairt ar ábhar agus doiciméadú coimhdeach a Foirmeacha Iarratais. Rinne sí athbhreithniú ar stíl agus ábhar a litreacha caighdeánacha agus cheap agus chuir feabhas ar an gcur chuige maidir le litreacha a scríobh. Rinne sí athfhorbairt freisin ar réimsí dá suíomh gréasáin le hionchorprú a dhéanamh ar na foirmeacha nua agus ar an doiciméadú coimhdeach.

Ina theannta sin, déanadh athbhreithniú fairsing ar nósanna imeachta riaracháin san Oifig d'fhonn simpliú a dhéanamh orthu agus buntáiste a bhaint, nuair ab fhéidir é, as uathobriú agus ríomhphróiseáil le feabhas a chur ar éifeacht. D'aithin an t-athbhreithniú inmheánach ar phróisis 61 feabhsúchán ar cuireadh 40 acu i bhfeidhm láithreach bonn. Tugadh tosaíocht don chuid eile, a raibh roinnt athruithe ar an gcóras ríomhairithe Riaracháin, agus cuirfead i bhfeidhm iad a luaithe agus a bheidh an t-airgead ar fáil chuige.

Rinne an Oifig iarracht inar chuir sí leis na cuspóirí seo agus sa chur chun cinn ar r-sheirbhísí an rialtais, ar theicneolaíocht a úsáid leis na seirbhísí a sholáthar go leictreonach. Chuige seo tosaíodh ar obair fhorbartha in 2009 le héascú a dhéanamh ar na mílte meabhrúchán athnuachana agus meabhrúcháin thar téarma a eisiúint go leictreonach trí r-phost in ionad tríd an bpost. Cuirfear an tionscadal seo i bhfeidhm go luath in 2010 agus is í an chéad chéim sa phróiseas í maidir le déileáil le formhór den chomhfhreagras isteach agus amach as an Oifig go leictreonach trí r-phost in ionad le páipéar agus tríd an bpost.

I rith 2009 rinne an Oifig forbairt ar mhodh oibre nach mbeadh na mílte comhad páipéir á gcruthú níos mó do Phaitinní Eorpacha bronnta, á sonrú agus á ndeimhniú in Éirinn gach bliain a chuirtear ar Chlár na hÉireann. Déantar gach faisnéis maidir le Paitinní Eorpacha a stóráil go leictreonach anois agus déantar aon chomhfhreagras páipéir a fhaightear a scanadh agus a chur leis an gcomhad iomchuí leictreonach. Tháinig an modh oibre seo i bhfeidhm ar an 1 Eanáir 2010 agus éascaíonn sé rochtain ar gach comhad don fhoireann; tá laghdú déanta aige ar am próiseála agus beidh sábháil nach beag i gceist ar spás stórála.

Cuireadh cur i bhfeidhm an tionscadail le héascú a dhéanamh ar rochtain ar líne ar shonraíochtaí foilsithe ar phaitinní na hÉireann siar arís de dheasca srianta bhuiséid.

Ag teacht lena cuspóir straitéiseach maidir le feasacht a mhéadú ar MI i measc an phobail, lean an Oifig lena hiarrachtaí for-rochtana dírithe ach go háirithe ar earnáil na ngnóthas nua-thionscanta beaga agus ar mhic léinn. Tá earnáil na ngnóthas beag aitheanta mar eochair le cothú a dhéanamh ar fhorás agus ar iomaíocht san eacnamaíocht sa toadhcháil.

I rith 2009, bhí láithreach ag an Oifig ag réimse d'imeachtaí poiblí mar ar ghlacamar le deiseanna le faisnéis a leathadh agus le feasacht a ardú ar thábhacht MI agus ar conas é a chosaint. Thug an fhoireann cainteanna ar MI do rannpháirtithe ag "cúrsaí ar do ghnó féin a thosú" a d'eagraigh seacht mBord Fiontar Contae. Chuir an fhoireann taispeántais ar siúl agus chuir comhairle ar fáil ag 3 sheó ar Chomhairle Gnó (urraithe ag Banc na hÉireann agus Boird Fiontar Contae) i nGaillimh, Dún Laoghaire agus Corcaigh agus ag 7 dTaispeántas Fiontraíochta ag clúdach contaetha Chill Mhantáin, Dhún na nGall, an Chláir, Luimnigh, Thiobraid Árann, Bhaile Átha Cliath agus Chill Chainnigh. Ina theannta sin, tionóladh seimineáir in Institiúidí Teicneolaíochta Cheatharlach agus Luimnigh.

Le Lá Domhanda do Mhaoin Intleachtúil a mharcáil chuir Oifig na bPaitinní sraith imeachtaí ar siúl le linn lae oscailte ag an oifig ar an 27 Aibreán 2009. Thug ball foirne ó Oifig na bPaitinní agus ionadaí ó Fhiontraíocht Éireann cainteanna ar MI agus tráchtálaíocht do ghrúpa daoine ó earnáil na ngnóthas beag agus do dhaoine ar spéis leo gnólachtaí nua-thionscanta. Ba é buaic an lae oscailte gur bronnadh duaiseanna ar rannpháirtithe sa chomórtas don Aireagóir Sóisearach 2009 (dírithe ar dhaltaí bunscoile), a raibh "Nuálaíocht Ghlas mar eochair do thodhchaí slán" mar théama aige. Is é atá i gceist leis an gcomórtas seo feasacht a spreagadh i ndaltaí bunscoile ar nuálaíocht agus aireagáin agus le tosú ar spéis a chur in eolaíocht agus innealtóireacht. D'fhreastail os cionn 200 duine (daltaí, múinteoirí, tuismitheoirí agus lucht gnó) ar imeachtaí le linn an lae oscailte. Cuireadh agallamh ar an gcéad duaisbhuaiteoir, ó Bhunscoil Rath Fhearnáin, ar chlár nuachta Six One RTÉ.

D'éirigh le hOifig na bPaitinní spéis shuntasach a chruthú sna meáin do Chomórtas an Aireagóra Sóisearaigh le haltanna á scríobh i ngach nuachtán náisiúnta, réigiúnach agus áitiúil agus sna nuachtáin saor in aisce i mBaile Átha Cliath agus i gCill Mhantáin. Tá sé ar intinn Seimineáir Ghnó agus Comórtas an Aireagóra Sóisearaigh a reáchtáil arís in 2010.

Faoi mar a tharla i mblianta roimhe seo ba thaispeántóir í an Oifig ag Taispeántas Eolaí Óg agus Teicneolaíochta BT. Déanann an Oifig urraíocht ar dhuais ag an Taispeántas a bhuaidh Liam



McCarthy agus John O'Callaghan ó Chionn tSáile i gCorcaigh dá n-aireagán ar mhodh saor agus éifeachtach le hionfhabhtú a aimsiú i mbainne bó ag úsáid gnáthleacht níocháin. Ba bhuaiteoirí foriomlán iad na mic léinn ag Taispeántas Eolaí Óg agus Teicneolaíochta BT agus chuardar ar aghaidh mar ionadaithe na hÉireann ag comórtas Eolaí Óg na hEorpa i bPáras i Meán Fómhair agus ghnóthaigh ceann de na trí príomhdhuaiseanna.

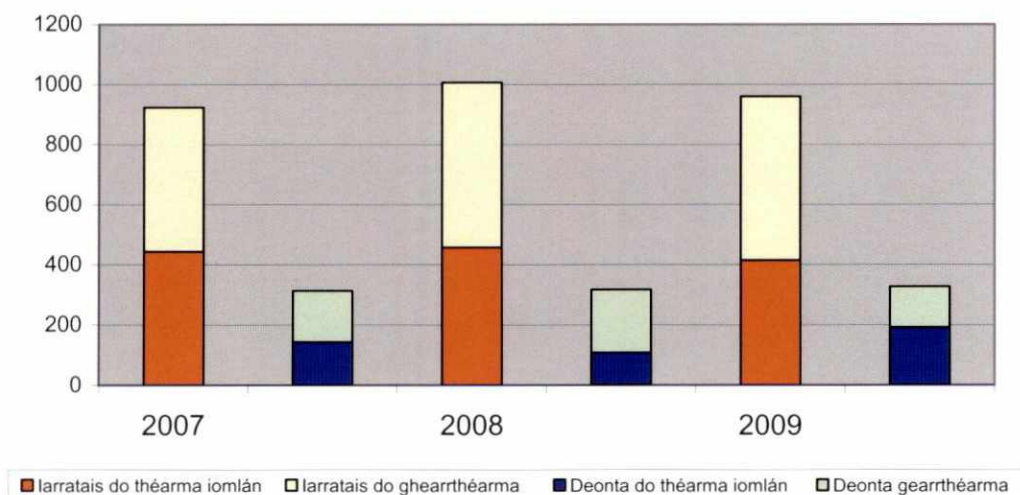

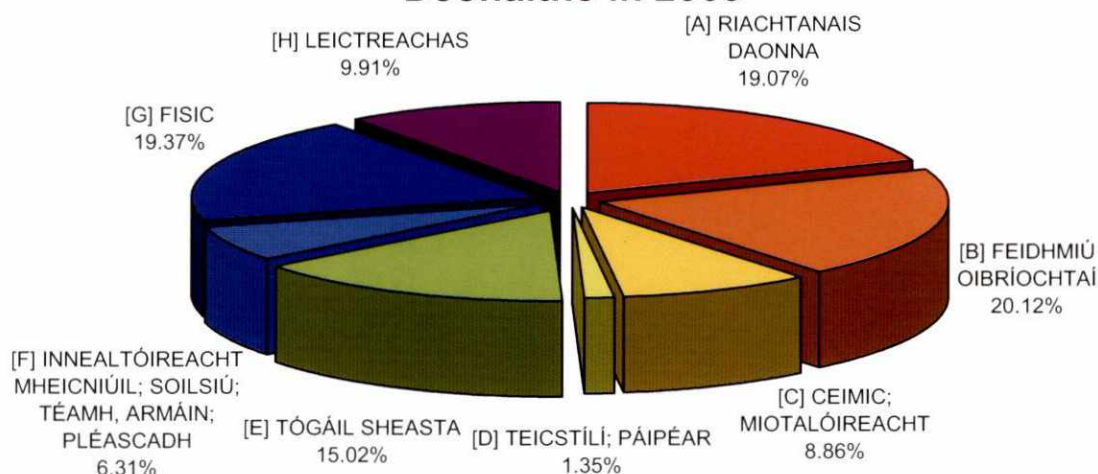

### Aicmithe de réir Choidanna IPC do Phaitinní Deonaithe in 2009



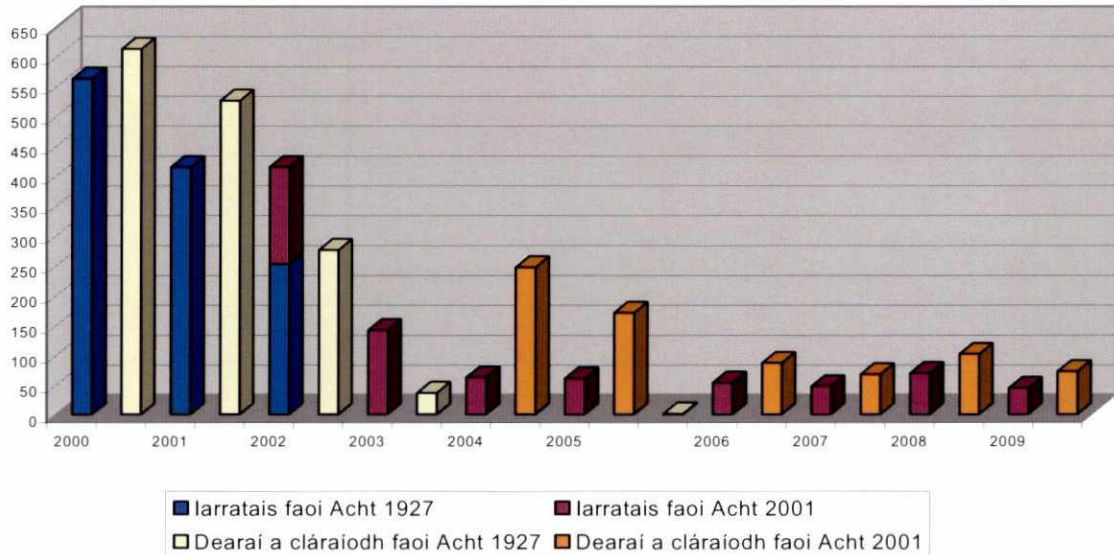

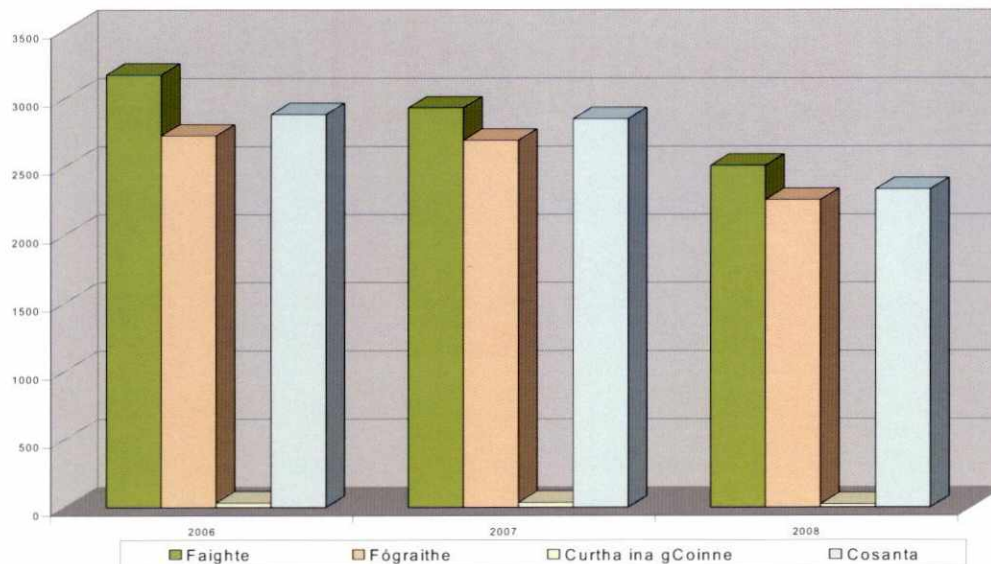
