Foreword of the Controller of the Irish Patent Office

I have the honour to submit my Annual Report to the Oireachtas for the year ended 31 December 2011, in accordance with the provisions of Section 103 of the Patents Act, 1992.

The Patents Office is the statutory office responsible for the granting and registration of intellectual property rights in Ireland, specifically patent, trade mark and industrial design rights. Innovation and creativity are important elements in gaining a competitive edge in the marketplace and for many business enterprises intellectual property is one of their most important assets. Through the provision of these services, the Office aims to assist people and businesses realise the full economic potential of their intellectual property.

My Report is in respect of the execution of my statutory functions under the Patents Act, 1992, the Patent (Amendment) Act 2006, the Trade Marks Act, 1996; the Industrial Designs Act, 2001, the various Statutory Rules and Regulations made under these Acts; and the European Communities (Supplementary Protection Certificate) Regulations. Decisions under these Acts, Rules and Regulations rest with me in my statutory capacity, subject to certain rights of appeal to the High Court. I also have certain statutory functions under the Copyright and Related Rights Act, 2000. In the main, these functions are concerned with dealing with registration of copyright licensing bodies, references and applications relating to licensing schemes operated by those bodies and the resolution of disputes regarding royalty amounts arising mainly in the area of public performance of sound recordings.

In addition to administering the relevant legislation and registers, the Patents Office performs a number of operational functions including:

- Processing applications for patents, trademarks and industrial designs.
- Implementing international agreements.
- Providing assistance and information on industrial and intellectual property to clients.
- Administering proceedings before the Controller in relation to IP rights and conducting hearings on oppositions to trademark registrations.
- Maintaining the registers of patent and trademark attorneys
- Acting as a receiving office for the World Intellectual Property Organization (WIPO), the European Patents Office and the Office for Harmonisation in the Internal Market (OHIM).
- Contributing to policy development on IP rights.

My Annual Report provides information on how the Office has discharged these functions and is supported by a range of business statistics.

I would like to extend my sincere thanks to the staff of the Office for all their hard work during 2011 and their commitment to continued improvement of services.

General Commentary on Objectives and Activities

The central mission of the Patents Office is

"To provide an efficient and effective system of industrial property protection that will encourage technological progress and promote enterprise through the implementation by the Office of the relevant legislation".

This is to be achieved through the protection of intellectual property rights in the fields of patents, trademarks and designs and the proactive dissemination of relevant knowledge and information in conjunction with each of these activities.

In 2011 the Office published its Strategy Statement for the period 2011 to 2013 which sets out the Office's strategic direction for the next 3 years. The aim of the Strategy Statement is to facilitate an environment in Ireland where individuals are able to achieve their rights and entitlements under the various pieces of IP legislation to the greatest extent possible and according to their needs. It is also intended to ensure that staff recognise and work towards achieving a common set of goals for the future development of the Office and its activities. The Office's business plans for each of the next three years will, in turn, focus on the key tasks necessary to achieve the high level objectives set out in the Strategy Statement.

The following commentary and accompanying statistical report considers the activities of the Office during 2011 in the context of six strategic objectives set out in the Strategy Statement. These objectives are seen as central to fulfilling the mission of the Office and maintaining its operational efficiency. The mission and strategy of the Office also ties in with the wider national objectives of supporting and encouraging enterprise and innovation and fostering an effective business environment in Ireland.

Objective (1)


Continue to grant patents and register trade marks and designs based on efficient administrative procedures and standards of service (which are in line with those reflecting best international practice and which meets the needs of customers).

In recent years, intellectual property rights (IPRs) have begun to take on a more significant role in Ireland's economy. There is now recognition that an ability to develop innovative ideas and to commercialise those ideas can be a significant contributor to economic success, - particularly for small and medium sized enterprises. Individual entrepreneurs seeking investment to develop new ideas, provide services, launch new brands and designs are now more cognisant of the value of IPR's and are more likely to promote their ownership of IPR's when preparing business plans or making a case for capital investment in their business.

The explosion of the Internet has brought about a mixture of threats and opportunities in IP. The virtual world has brought new business opportunities for enterprises to exploit copyright and trade mark ownership for selling products in the online marketplace. At the same time, there is a challenge to ensure that the rights of creators can be protected in the online environment notwithstanding rapid technological advancement.

Notwithstanding the increased awareness of IPR's in recent years and the opportunities to exploit and use IPRs at home and abroad, the economic downturn continues to have a significant impact on the filing of applications for these rights. The filing of new national patent, design and trade mark applications have all suffered declines of varying degrees in the period covered by the last strategy statement and this trend continued into 2011.

The Patents Office monitors patent and trade mark applications and renewals on a quarterly basis to gauge IP activity in Ireland and also consequential effects on the level of the Office's fee income. Previous quarterly reviews revealed a general downward trend in each quarter since 2008 reflecting the continuing economic recession. The WIPO report *World Intellectual Property Indicators 2011*, shows that intellectual property filings worldwide rebounded strongly in 2010 after considerable decline in 2009. While growth in IP filings outstripped the overall economic recovery rate in several of the larger economies such as China, the US and Japan, this was not the case for a large number of smaller countries like Ireland where declines continued in 2010 and again in 2011. Indeed, the picture at the end of 2011 shows an overall downward trend in filings which suggests that it may be some time before we see any improvement in these indicators.

- Applications for national patents continued to decline sharply. National long term Patent filings received during 2011 were down 34% on 2010 (from 350 to 230) while the number of short term patent applications filed was down 25% on 2010 (from 442 to 331).
- Applications for Supplementary Protection Certificates increased slightly (by 8%) from 38 in 2010 to 41 in 2011.
- Applications for the registration of industrial designs which has been at a very low level since 2003 when the Community Design registration system first came into being, showed slight increases in 2009 and 2010 but fell back by 15% in 2011 (from 54 to 46).
- The total number of National trade mark applications received in 2011 showed a very marginal increase of 0.5% over the 2010 figure (from 2,239 to 2,251) However, international applications for marks seeking protection in Ireland continued to decline, down 8% by comparison to 2010 (from 1,530 to 1,410).

The data indicates that the recession is continuing to impact on the filing of applications for the registration of IP rights in Ireland. It is also indicative of a continuing decline in business confidence, allied to difficulties in accessing finance, which impacts on investment in innovation.

Declines in business volumes and in particular decisions by business not to maintain their IP rights in force, impacted on the Office's fee income. Net receipts accruing to the exchequer in 2011 were down slightly by 5.6% on 2010 (from €8.8m. to €8.3m.). The greater proportion of the Office's fee income comes from renewal fees on European Patents and so far income from these renewal fees amounting to €5.7m. has continued to increase year on year (up 0.7% on 2010). This relatively stable income stream has, in part, compensated for declines in other fee income.

The development of a strong customer service ethos is an integral part of the Office's Customer Service Action Plan. The Plan sets out a series of customer service targets against which performance of the Office in respect of the processing of applications for IP rights, their registration and subsequent administration is monitored during the year. The level of performance against specific customer service targets achieved during 2011 is reported on in some detail further on in this report. Performance was very satisfactory overall with levels of achievement recorded in the upper quartile in all cases. The Office seeks to avail of every opportunity to streamline and as far as possible automate its processes and file management and its success in this regard is evidenced by the growing number of targets which are fully met. The Office has embarked on a cooperation project with OHIM which will facilitate the online filing of trade mark applications in 2013, allow improvements in application processing and contribute to further improvements in performance levels.

Objective (2)

Seek to incorporate new technology in order to improve systems and procedures and service to customers and which will also have regard to the demands of the information society and e-business.

The Government has continued to emphasise the need for quality and efficiency in the delivery of services to customers and accordingly the Office continued to focus on its role in relation to the effective and efficient delivery of services. Our commitment to quality customer service is outlined in our Customer Service Action Plan 2010 – 2013, which is available on our website. 93% is the average level of achievement against target for the 35 customer service targets which establish optimum time limits for carrying out various customer focused activities and tasks. These are detailed in the "Performance Targets" section of the report. During 2011, staff continued to refine the work processes and technology solutions that underpin its core products and services to provide more efficient service delivery. The following two examples are illustrative of improvements obtained as a result of refining work processes.

- The time taken to process agent filed Short Term Patent Applications from filing to the grant approval stage has been reduced from an average of 9 months in 2010 to currently 6 months or less.
- The time taken to process a properly completed trade mark application (where the Office raises no objections) from filing to acceptance was 13 weeks in 2010 and is now less than 6 weeks.

A significant percentage of the Office's business transactions — particularly those related to the receipt and processing of applications are paper-based, which hampers efficient service delivery. Recognising this, since 2010, the Office has pursued an

e-communications programme which has the aim of improving service delivery and more efficient processing. The project initially facilitated the issuing of thousands of renewal reminders and overdue reminders electronically by Email instead of by post and was further expanded to include other correspondence in 2010 and 2011. Some 12,000 items of correspondence are now issued by Email each month. The objective is to combine electronic filing, electronic file processing and electronic communications in a way that will facilitate the introduction of paperless processing in the Office in the next few years.

Paperless processing has already been introduced in respect of some 30,000 European Patents which are designated and validated in Ireland each year. Data related to these European Patents is received and stored electronically and this has facilitated ease of access to the files for staff, has reduced processing time and has reduced the requirement for storage space for paper files. The report of the Innovation Task Force, published in March 2010, included a recommendation that the Office should introduce electronic and after hours filings. While a detailed requirements analysis had been completed, the need to consider and evaluate specific e-Forms technology which had been proposed by the Department's IT Unit, caused a significant delay to the commencement of this project. However, in 2011 the Office decided to participate with the OHIM and a number of European IP Offices in a Future Software Package project which will facilitate the introduction of a system of online filing for trade marks in 2013. The development and integration work involved in bringing this project to fruition is being funded under the OHIM Co-operation fund and will enable the Office to offer a system which is on a par with some of the major European Offices which are also involved in the project and at a much lower cost than if it had commissioned the development work itself.

As an interim measure to meet the need to introduce electronic and after hours filing and pending the progress on the online filing project, the Office introduced an electronic drop box which facilitates the submission of encrypted patent, trade mark and design applications and associated documents electronically and securely via the Internet. The drop box facility is not for single or one off applications but rather is for use by persons or firms which make or intend to make a number of applications for intellectual property rights in the course of a year. At the end of 2011, 10 firms were availing of the electronic drop box facility.

In addition, the Office received sanction to establish two new bank accounts which allowed it to improve the fee payment options available to its customers. In line with Government policy to promote the increased use of electronic payments in the public service and throughout the economy, 89% of the Office's statutory fees are now paid electronically compared to 64% in 2010.

During 2011, a number of ICT software and hardware upgrades were effected which will ensure that the Office's core business systems and their technical infrastructure remain current. In addition, six substantive enhancements to the PTOLEMY administration system were developed and implemented in 2011, all of which were aimed at improving operational efficiency. The Office will also upgrade its in-house trade mark search system (ACSEPTO) to the latest version which is also used by OHIM (The Community Trade Mark Office), the UKIPO and several other European Offices. The upgrade is in line with best international practice and will make for more efficient searching which is an essential part of processing and examining trade mark applications. It includes more features, including image recognition, and provides an opportunity to consider and implement improvements to the existing search processes and procedures.

Objective (3)

Contribute to the drafting and subsequent implementation of any new IP legislation which creates functions for the Controller.

The Intellectual Property Unit (IPU) of the Department of Jobs, Enterprise and Innovation has responsibility for intellectual property policy and preparation of legislation in this field. The Patents Office furnishes advice on these matters, in particular on the impact of proposed legal or regulatory changes on the work of the Office. In November 2009, the role of Controller and Head of the IPU were vested in the same individual. This dual responsibility has facilitated greater coordination between the policy and operational functions.

During 2011, the Office made proposals and provided input to the Intellectual Property unit of the Department in relation to the drafting of the following matters:

- The Patent (Amendment) Rules 2011 (SI No 79 of 2011)
- The regulatory impact analysis and draft legislation to provide for the ratification and implementation of the Singapore Treaty.
- The regulatory impact analysis on the Review of the Patents Act 1992
- Draft Patents Trade Marks and Designs (Fees) Rules

Objective (4)

To increase awareness of intellectual property.

Once again, a key challenge in a period of faltering economic recovery and weak domestic demand has been to raise the awareness and understanding of Irish business and society about how to make the best use of the IP system when undertaking innovative and new business projects. The Innovation Task Force Report released in March 2010 recommended that there should be a more coordinated approach in delivering the Government's wider innovation policy in relation to IP training, awareness raising, the provision of advice and initiatives and supports for business and industry. During 2011, with this recommendation in mind, the Office sought to increase cooperation with The Enterprise Europe Network, Enterprise Ireland and the County Enterprise Boards through delivering a further series of one-day regional seminars, aimed at the 'small business' community, entrepreneurs and inventors, on the theme of 'Building a Business on Your Ideas'. The seminars focused on making business more aware of IP, of the possibilities to exploit the value of the IP inherent in most businesses and the support structures that are available for small businesses and start-ups from the State and Europe. Seven of these seminars took place in 2011 in Cork, Galway, Dundalk, Kilkenny, Dublin, Waterford and Sligo in conjunction with the Institutes of Technology. Over 600 people in total attended, with a number of seminars fully booked or at capacity.

The seminars were made more interesting and relevant as a result of participation by private sector speakers from the Association of Patent and Trade Mark Attorneys, the company 'Technology from Ideas' and the local entrepreneurs, who gave of their time on a no-fee basis

In line with its strategic objective to increase awareness of IP among the public, the Office continued with its outreach efforts directed particularly at the small business startup sector and students. Altogether, the Office participated in some 16 events speaking on IP at start your own business courses and at business advice and enterprise exhibitions and shows.

The Patents Office held 27 IP clinics in 2011. The clinics give an opportunity to members of the public, inventors, entrepreneurs and business people to discuss with Patents Office staff on a one to one basis, their ideas and matters concerning IP (patent, trade mark or design) applications they intend to make or have already made to the Office. This approach can be particularly helpful in providing basic guidance on procedures and forms required for the registration of IP rights, the process of obtaining IP protection in Ireland or abroad and the timeframes involved. Assistance in constructing a do-it-yourself search strategy for patents, trade marks or registered designs and accessing and using online patent, trade mark and design databases is also provided.

The Office also continued to promote awareness of IP amongst second level students, parents and members of the public attending the BT Young Scientist & Technology Exhibition. The Junior Inventor Competition which was held in conjunction with World IP day in April also gave an opportunity to promote invention and innovation in primary schools around the country.

BT Young Scientist & Technology Exhibition

The annual BT Young Scientist & Technology Exhibition took place in the RDS, Dublin from 12 -14 January 2011. With over 500 exhibitors, this year proved to be one of the largest. The exhibition has long been the constant in encouraging interest in science in secondary and primary schools. The Irish Patents Office once again took a stand for the duration of the exhibition. The Office has found that our presence at the exhibition is a useful avenue for imparting knowledge on intellectual property to the younger generation and to offer advice to participants in the Young Scientists Exhibition on patenting. The Office continued with its sponsorship of a special award at this year's event. The Irish Patents Office Award is made to the student or group of students whose project best demonstrates the use of technology in new or improved applications, enhanced efficiencies and novel innovations.

The winner of the 2011 Patents Office sponsored prize was Quinn Unger from Mount Saint Michael, Rosscarbery, Cork with his project; "A single pedal replacement for double bass pedals—i.e. the substitution of the drive-shaft operated double bass pedals with a single pedal design to free the "hi-hat" for the drummer's convenience".

Junior Inventor 2011

The aim of the Junior Inventor competition is to encourage children to be innovative and creative in finding solutions to everyday problems and to also hopefully sow the seeds of interest in science and engineering at an early age. The 2011 competition held to celebrate World Intellectual Property Day on 26 April, featured over 2,500 entries from 234 schools throughout Ireland. The 2011 winners were a group of 6th class students, Andrew Doran, Roisin Connolly, Kate Dowling and Abbie Byrne from Scoil Naomh Iosaf, Baltinglass. Co. Wicklow. Their winning entry was entitled "Cinema Seat Availability" for a lighting system for cinemas that makes it easier to find a seat in the dark. The group said that their idea was that a tiny green light would be visible on a cinema seat which was upright and not in use. If a seat was in use or the occupant temporarily leaves, the light on the seat will show red for a period of ten minutes. After this time it would change back to green to indicate that the seat was once again available.

Minister Sean Sherlock TD awarded prizes at a prize giving ceremony in Kilkenny.

Objective (5)

Recognise staff as a key asset of the Office and utilise business planning and individual performance management and development in order to improve business performance and processes and enhance organisational effectiveness.

The ongoing commitment of staff, at all levels, to provide an efficient quality service, initiate and deliver change and continue to improve work practices has allowed the Office to deliver an efficient and quality service with less staff resources. As of 31 December 2011, the Office had 57 authorised posts –2 less than in 2010. However, when career breaks, work-sharing and other family friendly working arrangements are taken into account, the Office operated with a staffing level of 50 full time equivalents during 2011.

The Office is committed to ensuring that all staff performance is appraised regularly and that staff reviews are completed in a timely fashion. In accordance with the Performance Management Development System (PMDS) operated in the Office, a development plan for training was drafted which took into account the various training needs which staff had identified in their personal development plans for 2011. Outside of continuing on-the-job training, staff in my Office undertook a total of 79.5 training days during 2011. Training was provided in areas such as project management, information and communication technology skills, presentation skills and communications and assertiveness skills.

As part of the Government's National Climate Change Strategy 2007 to 2012, the Patents Office has been participating in a pilot staff energy awareness scheme being run by the Office of Public Works in 20 Government Buildings throughout the country. The scheme has a target of reducing energy consumption through a local energy conservation campaign, energy workshops and monitoring the performance of heating/air conditioning equipment. In 2011, the Patents Office received a prize for achieving a significant reduction in gas and electricity consumption, and for the consequent reduction in CO2 emissions over the period 2007 to 2011 in the category of naturally ventilated buildings.

Objective (6)

To represent Ireland at international fora.

Patents Office staff represent Ireland on the Administrative Council of the EPO and its various Committees, the Administrative Board and Budget Committee of OHIM and several of its technical and liaison committees which deal with various issues concerning intellectual property. In addition, staff participate in meetings of governing and technical bodies of the World Intellectual Property Organisation (WIPO) (which administers both the Patent Co-operation Treaty and arrangements under the Madrid Protocol dealing with international trade mark applications) in addition to a number of international IP treaties.

Both the EPO and the OHIM offer alternative routes to obtaining IP protection in Europe and the Office's involvement with these organisations is aimed at ensuring that Irish interests are appropriately represented, at keeping abreast of best practice at an international level and to facilitate collaboration with other national and international industrial property offices.

The Office has bilateral cooperation programmes with the EPO and OHIM under which it receives assistance towards participation in various IP awareness raising events, specialist IP training, ICT projects to facilitate IP data exchanges, the development of tools to provide better access to IP information etc. Our participation also facilitates dialogue on the content and structure of cooperation programmes between those organisations and other national IP Offices in Europe which in turn enables the Office to further enhance or develop its customer services.

International Co-operation



The Office participates in cooperation activities with its international counterparts, the Office for Harmonisation of the Internal Market (OHIM) and the European Patents Office on a number of projects, which are designed to promote harmonisation across national IP offices, and make things easier for users of the patent, trade mark and design systems.

The following are examples of some of the co-operation projects undertaken in 2011.

EUROCLASS

EUROCLASS is an online tool that allows trade mark applicants and users consult a list of goods and services that are acceptable to the seventeen participating Offices. It is designed to assist trade mark applicants to identify acceptable terms and to classify correctly their goods and services into the right classes. If a term is listed in the Irish EUROCLASS database it will be accepted as valid. Where no entry is found, a list of alternative acceptable terms in the classes searched may be identified. If no entry for the proposed term exists in EUROCLASS the Office may seek clarification from the Applicant

The system is based on the 9th Edition of the Nice Classification managed by WIPO. The Alphabetical List of the Nice Classification contains c. 10,000 entries in English and the harmonised database has in excess of 100,000 English entries. WIPO will act as mediator in the event of any dispute between the participants.

The EUROCLASS tool was developed as a cooperation project with the OHIM and national trade mark offices from a number of EU member states. It is hosted by the OHIM website and may also be accessed from the pages dealing with trade mark classification on the Patents Office website.

TMview

TMview is another cooperation project between the OHIM, WIPO and EU national trade mark offices. It is an online consultation tool hosted by OHIM which provides users with the possibility to search, **free of charge**, the trade marks of all official trade mark offices which are participating in the project. With the gradual integration of all offices and organisations, TMview aims to be the platform for registered trade mark data from all 27 EU Member States in addition to the information available from OHIM and WIPO. The Irish Patents Office began discussions with OHIM in 2011 with a view to integrating its trade mark database and register information in TMview.

SENIORITY

Articles 34 and 35 of Community Trade Mark (CTM) Regulation, and Rule 8 of the CTM Implementing Regulations, provide a legal basis for seniority claims. Based on these provisions, applicants or proprietors of a CTM who already hold a prior identical registered national trade mark in one of the EU Member States for identical goods and services may claim the seniority of that mark. This allows them to preserve their prior rights even if they surrender their national trade mark or do not renew it. The right obtained by the national registration will continue to exist under the umbrella of the CTM.

The effective implementation of seniority claims depends on the existence and maintenance of reliable data in the databases and registers of the relevant national offices, which are ultimately one of the key sources for the information that the end user receives. During 2011, the Office completed a cooperation project with the OHIM whereby the Office upgraded content of its trade mark register so as to indicate instances where the OHIM have notified the Office of a seniority claim in respect of an Irish national trade mark registration. It is also possible to link back from the Irish registration to the relevant CTM online register entry by clicking into the details of the CTM number for which the seniority of the national mark is claimed.

FEDERATED EUROPEAN PATENT REGISTER

Announced at the EPO Patent Information Conference in Ireland in October 2011, the EPO in cooperation with national patent offices has begun a programme of deep linking to data on national patent registers which makes legal status information on European patents more easily accessible.

Online inspection of the EPO's European Patent Register now allows access to the national record in the Irish Patents Register and in several national patent registers via the relevant deep link. The EPO is working on increasing the number of national registers that can be deep-linked in this way.

EUROTAB

Ireland being party to the European Patent Convention (EPC) shares a great deal in common with its 37 co-members in respect of patent practice. All EPC member states are required to reflect the principles of European patent law in their national legislation. Nonetheless, within each jurisdiction, emphasis and interpretation can differ according to national practice and tradition. EUROTAB is an annual round-table meeting to which patent examiners from each EPC member state and the European Patent Office (EPO) can meet to discuss topics of common interest or where there is divergence in national practice.

In May 2011, this meeting was hosted by the German Patent and Trademark Office (DPMA) at its headquarters in Munich. Ireland presented the lead paper on one of the main agenda items, namely "Supplementary Protection Certificates: national implementation and practice". Other issues discussed at the meeting were:

- Double patenting;
- Asian prior art searches;
- Interaction between Patent Offices and applicants/representatives: experiences in development and use of concepts of best practice.

2011 EPO Patent Information Conference

In October the Patents Office hosted the 2011 EPO Patent Information Conference in Kilkenny in the Lyrath Hotel and Conference Centre on the outskirts of the city. This conference, organised by the European Patent Office, has been running since 1991 and has grown to become one of the largest events of its kind in the Intellectual Property world. This year it brought some 320 delegates - patent searchers, information specialists and commercial providers of data and search services – from as far away as China, Australia and New Zealand. Many of these experts come from some of the most innovative companies on the global stage, such as Nokia, Siemens, Shell and Novartis.

The conference was opened by Minister Richard Bruton who highlighted the increasing importance of innovation and intellectual property in Ireland's economy. In his opening address Benoît Battistelli, the EPO President, remarked "it is quite simply the public's right to have access to patent information, which makes it our duty to publish patent data with maximum transparency." In this way he highlighted the importance of access to worldwide patent data, and drew parallels with the recent "open government" initiatives in the US and Europe.

Concentrating on the "open data" theme, one of the keynote speakers, Professor Nigel Shadbolt, from the University of Southampton and an advisor to the UK Government on how to transform public access to Government information, highlighted the opportunities available to companies to process much of this dormant government data into useful web and mobile applications for the benefit of citizens and communities. He also challenged all patent offices to make their valuable sources of data as open and accessible as possible.

Jim O'Hara, the recently retired CEO of Intel Ireland and the then Chair of the Government Taskforce on Research Prioritisation spoke on the topic "A high-tech view on patents and their impact on business development".

In addition to the formal conference presentations, there was also a series of small discussion groups on a diverse set of related topics such as the creation and maintenance of a worldwide patent legal status database, the enhancement of machine translation services for patent documents, and the importance of developing agreed standards for patent databases. An exhibition ran in parallel to the timetabled events with 30 stands manned by many of the big information companies in the IP field, such as Thomson Reuters, Questel and Dialog.




National patent applications by country of first applicant.



Requests for Supplementary Protection Certificates

A total of 41 requests for Supplementary Protection Certificates were received during the year under the European Communities (Supplementary Protection Certificates) Regulations, 1992 (medicinal) and 1996 (plant protection products). During the year, 16 certificates were granted (medicinal and plant protection), 3 requests were rejected and 1 request was withdrawn. At the end of the year there were 101 requests pending.

Note on Patent Classification

Patents are given classifications based on their technical content. Such classification allows retrieval of patents according to the nature of the inventions revealed therein. The International Patent Classification (IPC) consists of about 70,000 classification symbols divided between 8 basic sections (A to H), relating to different basic kinds of technology. In 2011, it was in its 9th edition (Int. Cl. (2009)).


A classification code is given for each inventive thing in a patent. A patent may contain two or more inventions as long as they are sufficiently related; for instance, a new chemical compound and its use as a medicine or herbicide, or a new laser and its use in eye surgery or data readers. Accordingly, a patent may need a number of classification symbols to cover the whole of its content.

The accompanying table and graph collates the total number of classifications allocated to granted patents in 2011. Each individual classification represents an inventive element disclosed in a patent, so this is akin to a tally of inventiveness. The classifications are grouped by IPC section.




Granted Patent Classifications by IPC section in 2011







References to the Controller under the Copyright & Related Rights Act, 2000

Under Section 38 of the Act, disputes between persons playing sound recordings in public and the owner of the copyright subsisting in the recordings, regarding the equitable remuneration payable to the copyright owner, may be referred to the Controller for determination.

Under Section 152 of the Act, where a dispute arises between the operator of a licensing scheme concerned with copyright works and a person, claiming that he or she requires a licence under the scheme, that person or operator may refer the scheme to the Controller for determination.

The Order was the subject of Judicial Review proceedings, the outcome of which provided that the reference be remitted back to the Controller for his determination and that the application should be treated as a fresh reference *ab initio*.

Legislation enacted in 2011

PATENTS

S.I. 79 of 2011 - the Patent (Amendment) Rules 2011.

These amendments to the Patent Rules 1992 align the Patent Rules with the European Economic Agreement (EEA) for the purposes of registering an Address for Service from EEA countries and to allow EEA patent agents to represent patent applicants in this country. In addition, this instrument amends the Patents Office Form 1 (Request for the Grant of a Patent), to allow applicants communicate with the Patents Office by e-mail, with extra sheets for supplementary information relating to additional applicants and inventors also included in the form.

COPYRIGHT

S.I. No 709 of 2011 European Communities (Artist's Resale Right) (Amendment) Regulations 2011.

These Regulations extend the artist's resale right to those to whom a resale right is transmitted (or deemed to be transmitted) after the death of the author of an original work of art. The right is extended for a period of 70 years after the death, in respect of sales whose contract date is on or after 1 January 2012.

Is onóir agam é mo Thuarascáil Bhliantúil a chur faoi bhráid an Oireachtas don bhliain dar críoch 31 Nollaig 2011, de réir phorálacha Ailt 103 d'Acht na bPaitinní, 1992.

Is oifig reachtúil í Oifig na bPaitinní atá freagrach as cearta maoine intleachtúla a thabhairt agus a chlárú in Éirinn, go speisialta cearta paitinne, trádmhairc agus dearaidh thionsclaíoch. Is eilimintí tábhachtacha iad nuálaíocht agus cruthaitheacht maidir le buntáiste iomáioch a bhaint amach ar an margadh do mhórán fiontraíochtaí gnó, agus tá maoine intleachtúil (MI) ar cheann dá sócmhainn is tábhactaí atá acu. Tríd na seirbhísí seo a sholáthar, is í aidhm na hOifige cabhrú le daoine agus le gnólachtaí acmhainneacht iomlán eacnamaíoch a maoine intleachtúla a bhaint amach.

Baineann mo Thuarascáil le feidhmiú m'fheidmeanna reachtúla faoi Acht na bPaitinní, 1992, Acht na bPaitinní (Leasú) 2006, Acht na dTrádmharcanna, 1996; Acht um Dheartháí Tionscail, 2001, na Rialacha agus na Rialúcháin Reachtúla éagsúla a déanadh faoi na hAchtanna seo; agus Rialacháin na gComhphobal Eorpach (Deimhniú Cosanta Forlíontach). Is ormsa atá cinneadh a dhéanamh faoi na hAchtanna, na Rialacha agus na Rialacháin seo de réir reachtaíochta, faoi réir chearta áirithe achomhairc chuig an Ard-Chúirt. Tá feidhmeanna áirithe reachtúla agam freisin faoin Acht Cóipchirt agus Ceart Gaolmhar, 2000. Baineann na feidhmeanna seo go, go príomha, le déileáil le clárú chomhlachtaí ceadúnaithe cóipchirt, tagairtí agus iarratais a bhaineann le scéimeanna ceadúnaithe a bhíonn á bhfeidhmiú ag na comhlachtaí seo agus réiteach díospóide maidir le méid dleachta ag éirí den chuid is mó as réimse léirithe phoiblí ar thaifead fuaimé.

- Feidhmiú mar oifig ghlaetha don Eagraíocht Dhomhanda um Maoin Intleachtúil (EDMI), Oifig na bPaitinní Eorpacha agus an Oifig um Chomhchuibhíú sa Mhargadh Inmheánach (OCMI).
- Cur le forbairt beartais ar chearta MI.

Tá seo le baint amach trí chearta maoine intleachtúla a chosaint i réimsí paitinní, trádmharcanna agus dearaidh agus forleathadh réamhgníomhach ar eolas agus faisnéis ábhartha in éineacht le gach ceann de na gníomhaíochtaí seo.

I 2011 d'fhoilsigh an Oifig Ráiteas Straitéise don tréimhse 2011 go dtí 2013 a leagann amach treo straitéiseach na hOifige go ceann 3 bliana. Is í aidhm an Ráitis Straitéise seo éascú a dhéanamh ar thimpeallacht in Éirinn mar ar féidir le daoine a gcearta agus a dteidlíochtaí a bhaint amach faoi na píosaí éagsúla reachtaíochta MI chomh mór agus is féidir é agus de réir a riachtanais. Tá sé ar intinn freisin a chinntí go n-aithníonn an fhoireann agus go n-oibríonn siad i dtreo comhspriocanna a bhaint amach d'fhorbairt na hOifige agus a gníomhaíochtaí sa todhchaí. Díreoidh pleannanna gnó na hOifige do na trí bliana atá romhainn, ina dturas, ar na príomhthascanna atá riachtanach leis na cuspóirí ardleibhél atá leagtha amach sa Ráiteas Straitéise a bhaint amach.

Sa tráchtairacht seo a leanas agus sa tuarascáil staitisticiúil atá in éineacht leis féachtar ar gníomhaíochtaí na hOifige i rith 2011 i gcomhthéacs sé chuspóir straitéiseach a leagadh amach sa Ráiteas Straitéise. Feictear go bhfuil na cuspóirí seo lárnach maidir le bunchuspóir na hOifige a bhaint amach agus a héifeachtúlacht oibríochtaí a choimeád. 
Leanúint le paitinní a cheadú agus trádmharcanna agus dearaí a chlárú bunaithe ar nósanna imeachta riarcháin agus caighdeán seirbhíse éifeachtacha (atá ag teacht leo sin is fearr a thagann le deachleachtas idirnáisiúnta agus a fhreastlaíonn ar riachtanais chustaiméirí).

Le blianta beaga anuas, tá ról níos suntasaí ag cearta maoine intleachtúla (CMIanna) i ngeilleagar na hÉireann. Tá aitheantas anois ann gur féidir leis an gcumas smaointe nuálacha a fhorbairt agus tráchtálú a dhéanamh ar na smaointe sin, cur go suntasach le rath eacnamaíoch – go háirithe do ghnóthais bheaga agus mheánmhíde. Tá fiontralú indibhidiúla, a bhíonn ag lorg infheistíochta le smaointe nua a fhorbairt, seirbhísí a sholáthar, brandaí agus dearaí nua a sheoladh níos tuisceanaí anois ar luach CMIanna agus is dóchúla go gcuirfidís a n-úinéireacht ar CMIanna chun cinn agus pleannanna gnó á n-ullmhú acu nó agus cás á dhéanamh acu d'infheistíochta chaipitiúil ina ngnó.

Tá méadú ollmhór an Idirlín tar éis meascán de bhagairtí agus deiseanna a chruthú in MI. Tá an domhan fíorúil tar éis deiseanna nua gnó a chruthú d'fhiontraíochtaí le feidhm a bhaint as úinéireacht chóipchart agus trádmharc le tárgí a dhíol ar an margadh ar líne. Ag an am gcéanna, tá cath á throid i gcónaí lena chinntí de chearta na gcruthaitheoirí, gur féidir iad a chosaint sa timpeallacht ar líne in ainneoin dul chun cinn tapaidh tecneolaíochta.

In ainneoin an méadú ar fheasacht ar CMIanna le blianta beaga anuas agus na deiseanna le feidhm agus úsáid a bhaint as na CMIanna sa bhaile agus thar lear, tá tionchar i gcónaí ag an gcor chun donais eacnamaíoch ar iarratais á chomhdú do na cearta seo. Tá laghdú a bheag nó a mhór tagtha tagtha ar chomhdú iarratas nua paitinne, dearaidh agus tradmhairc náisiúnta sa tréimhse a chlúdaigh an ráiteas straitéise deireanach agus lean an treocht seo i 2011.

Iarratais Náisiúnta ar Phaitinní, Trádmharcanna agus Dearáí 2001 – 2011



Déanann Oifig na bPaitinní monatóireacht ar iarratais agus athnuachaintí paitinne agus trádmhairc ar bhonn ráithiúil le tomhas a dhéanamh ar ghníomhafocht MI in Éirinn agus freisin ar na torthaí dá réir ar leibhéal ioncaim na hOifige ó tháillí. Léirigh athbhreithnithe ráithiúla roimhe seo treocht ginearálta anuas i ngach ráithe ó 2008 ag teacht leis an meathlú leanúnach geilleagrach. Léiríonn tuarascáil TDMI *Táscairí Dhomhanda um Maoín Intleachtúil 2011*, gur tharla aisphreabadh láidir ar chomhdú maoine intleachtúil i 2010 tar éis dó titim go mór i 2009. Cé go raibh an fás ar chomhdú MI chun tosaigh ar an ráta foriomlán téarnaimh gheilleagrach i roinnt de na geilleagair mhóra mar an tSín, SAM agus an tSeapáin, níorbh amhlaidh do líon mór tíortha beaga mar Éire mar ar lean an meathlú i 2010 agus arís i 2011. Go deimhin, léiríonn an pictiúr ag deireadh 2011 treocht foriomlán anuas i gcomhdú rud a thugann le fios go mb'fhéidir go mbeidh tamall ann sara dtagann feabhas ar na táscairí seo.

- Lean an laghdú géar ar iarratais ar phaitinní náisiúnta. Bhí comhdú fadtéarmach Paitinne náisiúnta a fuathas i rith 2011 síos 34% ar 2010 (ó 350 go dtí 230) agus bhí líon na bpaitinní gearrthéarmacha a comhdaíodh síos 25% ar 2010 (ó 442 go dtí 331).
- Tháinig méadú beag ar iarratais ar Dheimhniú Cosanta Forlíontach (le 8%) ó 38 i 2010 go dtí 41 i 2011.
- Tháinig méadú beag ar iarratais ar dhearaí tionsclaíocha a chlárú, a raibh leibhéal an-íseal ag baint leo ó 2003 nuair a tháinig ann ar dtús don chóras cláraithe Dearadh Pobail, i 2009 agus 2010 ach tharla laghdú 15% arís i 2011 (ó 54 go dtí 46).
- Léirigh líon iomlán na n-iarratas ar thrádmharcanna Náisiúnta a fuarthas i 2011 méadú an-bheag de 0.5% ar fhigiúr 2010 (ó 2,239 go dtí 2,251). Mar sin féin, lean na hiarratais idirnáisiúnta ar mharcanna ag lorg cosanta in Éirinn ag laghdú, síos 8% i gcomparáid le 2010 (ó 1,530 go dtí 1,410).

Tugann na sonrái le fois go bhfuil tionchar ag an gcúlú eacnamaíochta i gcónaí ar chomhdú iarratas ar chlárú cearta MI in Éirinn. Léiríonn sé freisin an meath ar mhuinín lucht gnó, in éineacht le deacrachaí rochtain a fháil ar mhaoiniú, rud a h-iombualadh ar infheistíochtaí i nuálaíocht.

Bhí tionchar ag laghdú ar mhéid gnó agus go háirithe ag cinntí ghnóthaí gan a gcearta MI a choimeád i bhfeidhm, ar ioncam na hOifige ó tháillí. Bhí an glanfháltas ag fabhrú don státhiste i 2011 síos beagán de 5.6% ar 2010 (ó €8.8m go dtí €8.3m). Tagann formhór an ioncaim a bhaineann le táille na hOifige ó tháillí athnuachana ó Phaitinní Eorpacha agus go dtí seo tá an teacht isteach ó na táillí athnuachana seo ag méadú ó bhliain go bliain ar ionann iad agus €5.7m (suas 0.7% ar 2010). Tá an sruth ioncaim cuíosach seasmhach seo tar éis cúiteamh, i bpáirt, don laghdú ar ioncam ó tháillí eile.

Tá forbairt ar éiteas láidir seribhise do chustaiméirí ina chuid lárnach do Phlean Gníomhaíochta Seirbhise do Chustaiméirí na hOifige. Leagann an Pleán amach staith de spriocanna seirbhise do chustaiméirí lena ndéantar monatóireacht ar fheidhmíocht na hOifige i rith na bliana maidir le hiarratais ar chearta MI a phróiseáil, a chlárú agus a riadarbh ina dhiadh sin. Tuairiscírean go sonrach níos déanaí sa tuarascáil seo ar an leibhéal feidhmíocha a baineadh amach i rith 2011 de réir na spriocanna sonracha seirbhise do chustaiméirí. Bhí an fheidhmíocht an-sásúil go foriomlán leis na leibhéis a baineadh amach taifeadta sa cheathairí uachtarach i ngach cás. Is mian leis an Oifig gach deis a thapú le sruthlíníú agus le huathoibríú a dheánamh chomh fada agus is féidir é ar a próisis agus agus a bainistíocht comhad agus tá an rath ina thaobh seo le feiceáil sa bhfás ar líon na spriocanna a bhaintear amach go hiomlán. Thug an Oifig faoi thionscadal comhoibrithe le OHIM a éascóidh comhdú ar líne ar iarratas trádmharcanna i 2013; ceadóidh sé feabhsú ar phróiseáil iarratas agus curfidh sé le tuilleadh feabhas ar leibhéis fheidhmíochta.

larracht a dhéanamh ar theicneolaíocht nua a ionchorprú d'fhoínn feabhas a chur ar chórais agus nósanna imeachta agus ar sheirbhís do chustaiméirí agus a thógrfaidh ceann freisin d'éilimh an tsochaí faisnéise agus r-ghnó.

Leanann an Rialtas le béim a chur ar an ngá le cáilíocht agus éifeacht maidir le soláthar seirbhís do chustaiméirí agus dá réir sin lean an Oifig le fócas a chur ar a ról maidir le seirbhísí a sholáthar go héifeachtach. Tá imlíne ar ár dtiomantas maidir le dea-sheirbhís do chustaiméirí in ár bPlean Gníomhaíochta um Sheirbhís do Chustaiméirí 2010 – 2013, atá ar fáil ar ár suíomh gréasáin. Is é 93% an meánleibhéal de na spriocanna a bhaintear amach do na 35 sprioc seirbhise do chustaiméirí a leagann síos uasteorainn ama le gníomhaíochtaí agus tascanna éagsúla a bhíonn dírithe ar chustaiméirí a thabhair i gcrích. Tá mionsonraí orthu seo sa rannán sin den tuarascáil ar "Spriocanna Feidhmíochta".

I gcaitheamh 2011, lean an fhoireann le beachtú a dhéanamh ar phróisis oibre agus ar réitigh theicneolaíochta atá mar thaca lena dtáirgí agus a seirbhísí lárnacha, le soláthar níos éifeachtaí seirbhise a sholáthar. Léiríonn an dá shampla seo a leanas an feabhas a bhaineadh amach mar thoradh ar bheachtú ar phróisis oibre.

- Tá an t-am a thógrann sé le phróiseáil a dhéanamh ar iarratais ar Phaitinní Gearrthéarmacha ag gníomhaire chomhdaithe, ón gcomhdú go staid an fhaofa, laghdaithe ó 9 mí mar mheán i 2010 go dtí 6 mhí níos gorraí láthair.
- Ba é 13 seachtain a thógr sé i 2010 le phróiseáil a dhéanamh ar iarratas ar thrádmharc a bhí críochnaithe i gceart (nuair nach mbíonn aon chur ina choinne ag an Oifig) ó chomhdú go dtí go nglactar leis, agus tógann sé níos lú ná 6 seachtainíanois.

Tá céadán suntasach d'idirbhearta gnó na hOifige – go háirthe iad sin a bhaineann le fáil agus próiseáil iarratas, ar pháipéar, rud a chuireann isteach ar sheirbhís éifeachtach a sholáthar. Á aithint seo, ó 2010, tá an Oifig tar éis dul i mbun chláir r-chumarsáide d'fhonn feabhas a chur ar sholáthar seirbhíse agus próiseáil a dhéanamh níos éifeachtaí. I dtús báire rinne an tionscadal éascú ar na mílte meabhrúchán athnuachana agus meabhrúchán thar téarma a eisiúint go leictreonach trí r-Phost in ionad tríd an bpost agus cuireadh arís leis go n-áireofaí comhfhareagras eile i 2010 agus 2011. Eisitear timpeall le 12,000 mír chomhfhareagras trí r-Phost gach mí. Is é an cuspóir atá ann comhdú leictreonach, próiseáil ar chomhdú leictreonach agus cumarsáid leictreonach a nascadh ar bhealach a éascóidh próiseáil gan pháipéar a thabhairt isteach san Oifig sna blianta beaga romhaínn.

Tugadh próiseáil gan pháipeár isteach cheana féin maidir le timpeall 30,000 Paitinn Eorpach a shainítéar agus a dhearbháitear in Éirinn gach bliain. Faightear agus déantar stóráil ar na sonraí a bhaineann leis na Paitinní Eorpacha seo go leictreonach agus tá seo tar éis éascú a dhéanamh ar rochtain ar na comhaid don fhoireann, le laghdú ar am próiseála agus ar an ngá le spás stórála do chomhaid pháipéir.

Airíodh i dtuarascáil an Tascfhórsa Nuálaíochta, a foilsíodh i Márta 2010, moltaí go dtabharfadhbh an Oifig isteach comhdú leictreonach agus iar-ama. Cé gur críochnaíodh mionanailís ar riachtanais, cruthaíonn an gá atá le plé agus measúnú a dhéanamh ar theicneolaíocht r-Fhoirmeacha faoi mar a bhí molta ag Aonad TF na Roinne, moill suntasach ar thus a chur leis an tionscadal seo. Mar sin féin, i 2011 rinne an Oifig cinneadh a bheith rannpháirteach leis an OHIM agus le roinnt Oifigí MI Eorpacha maidir le tionscadal Pacáiste Bogearraí don Todhchaí a éascóidh córas comhdaithe ar líne a thabhairt isteach do thrádmharcanna i 2013. Tá an obair fhorbartha agus chomhtháithi atá i gceist chun an tionscadal seo a thabhairt i gcrích á maoiniú faoi chiste Comhoibrithe OHIM agus cuirfidh sé ar chumas na hOifige córas a thairiscint atá ar chomhchéim le cuid de na mórOifigí Eorpacha a bhfuil baint acu leis an tionscadal freisin agus ar costas i bhfad níos lú ná mar a bheadh air dá mbeadh coimisiúnú déanta aici féin ar an obair fhorbartha.

Mar bheart idirlinne le freastal ar an ngá atá le comhdú leictreonach agus iar-ama a thabhairt isteach agus go dtí go ndéantar dul chun cinn ar an tionscadal comhdaithe, thug an Oifig isteach bosca leictreonach anuas a éascaíonn iarratais ar phaitinní, trádmharcanna agus dearaí criptithe agus na doiciméid a bhaineann leo a chur isteach go leictreonach agus go sábhláit tríd an Idirlíon. Ní d'íarratais aonair ná aonuaire an bosca anuas ach é le húsáid ag daoine agus gnóthais a dhéanann, nó a bhfuil sé ar intinn acu iarratas a dhéanamh ar chearta maoine intleachtúla i gciathreamh na bliana. Ag deireadh 2011, bhí 10 ngnólacht ag úsáid saoráid an bhosca leictreonach anuas.

Ina theannta sin, fuair an Oifig cead dhá chuntas nua bainc a bhunú a chuir ar a cumas feabhas a chur ar na roghanna atá ar fáil dá custaiméirí le táillí a íoc. Ag teacht le polasaí an Rialtais maidir le méadú a dhéanamh ar úsáid a bhaint as íocaíochtaí leictreonacha sa tseirbhís phoiblí agus ar fud an gheilleagair, iocatar 89% de tháillí reachtúla na hOifige go leictreonach anois i gcomparáid le 64% i 2010.

I gciathreamh 2011, cuireadh roinnt uasgrádú bogearraí agus crua-earraí i bhfeidhm rud a chinnteoidh go bhfanann croíchórais ghnó na hOifige agus a mbonneagar teicniúil suas chun dátá. Ina theannta sin, déanadh forbairt agus cur i bhfeidhm ar sé fheabhsúchán substaintíúil sa chóras riaracháin PTOLEMY i 2011, a raibh gach ceann acu diríthe ar fheabhas a chur ar éifeachtúlacht oibríochtaí. Déanfaidh an Oifig uasgrádú freisin ar a córas inmheánach cuardaigh trádmharcanna (ACSEPTO) chuig an leagan is déanaí a úsáideann OHIM (Oifig Trádmharcanna an Chomhphobail), an UKIPO agus roinnt Oifigí Eorpacha eile. Tá an uasgrádú ag teacht le dea-chleachtas idirnáisiúnta agus éascóidh sé cuardach níos éifeachtaí ar chuid riachtanach de phróiseáil agus scrúdú iarratas ar thrádmharcanna é. Áirítear níos mó gnéith ann, ar a bhfuil aithint íomhá, agus soláthraíonn sé deis le measúnú agus forfheidhmiú a dhéanamh ar fheabhsú ar na próisis agus na nósanna imeachteach cuardaigh atá ann.

Tá freagracht ar Aonad Maoine Intleachtúla (AMI) An Roinn Post, Fiontar agus Nuálaíochta maidir le polasaí ar mhaoin intleachtúil agus maidir le reachtaíocht sa réimse seo a ullmhú. Soláthraíonn Oifig na bPaitinní comhairle ar na ceisteanna seo, go háirthe ar an tionchar a bheadh ag na hathruithe dlíthiúla agus rialála atá beartaithe ar obair na hOifige. I Samhain 2009, bhí ról an Ceannasaí agus Ceann an AMI dílsithe don pearsanta ceanna. Tá an défhreagracht seo tar éis éascú a dhéanamh ar chomhordú níos fearr idir pholasaí agus feidhmeanna oibríochtaí. I rith 2011, rinne an Oifig moltaí agus sholáthair sí ionchur d'aonad Maoine Intleachtúla na Roinne maidir le dréachtú na nithe seo a leanas:

- Rialacha na bPaitinní (Leasú) 2011 (IR Uimh 79 de 2011).

Arís, is é an príomhdhúshlán i dtréimhse téarnaimh stadach gheilleagrach agus éilimh lag sa bhaile ná feasacht agus tuiscint a ardú ar ghnó agus sochaí na hÉireann ar conas an leas is fearr a bhaint as an gcóras MI nuair a théitear i mbun tionscadal gnó nuálach agus nua. Moladh i dTuarascáil an Tascfhórsa Nuálaíochta a cuireadh amach i Márta 2010 gur chóir go mbeadh cur chuige níos comhordaithe ann maidir le polasaí níos leithne nuálaíochta an Rialtais a sholáthar maidir le hoiliúint MI, ardú feasachta, comhairle agus tionscnaimh agus tacáiochtaí a sholáthar do ghnó agus do thionscláiocht. Dhírigh na seimineáir ar ghnó a bheith níos mó ar an eolas maidir le MI, ar na féidearthachtaí le leas a bhain as luach MI atá bunúsach i bhformhór na ngnólachtaí agus ar na struchtúir tha-caiochta atá ar fáil ón Stát agus ón Eoraip do ghnóthais bheaga agus do ghnólachtaí nuathionscanta. Bhí seacht gcinn de na seimineáir seo ar siúl i 2011 i gCorcaigh, Gaillimh, Dún Dealgan, Cill Chainnigh, Baile Átha Cliath, Port Láirge agus Sligeach i gcomhar leis na hInstitiúidí Teicneolaíochta. D’fheastal os cionn 600, le roinnt den na seimineáir lán ar fad. Bhí an seimineáir níos spéisiúla agus níos ábharthaí mar thoradh ar rannpháirtíocht chainteoirí ón earnáil phríobháideach ó Chumann na nGníomhairí Paitinne agus Marcanna Trádála, an chuideachta ‘Technology form Ideas’ agus fiontraithe áitiúla, a thug a gcuid ama in aisce.

Ag teacht lena cuspóir straitéiseach maidir le feasacht a mhéadú ar MI i measc an phobail, lean an Oifig lena hiarrachtaí for-rochtana dírithe ach go háirithe ar earnáil na ngnóthas nua-thionscanta beag agus ar mhic léinn. Soláthraítear cúnamh freisin maidir le straitéis chuardaigh ‘déan féin é’ a cheapadh do phaitinní, trádmharcanna nó dearáí cláraithe agus rochtain a fháil, agus úsáid a bhaint as bunachair sonraí phaitinní, trádmharcanna agus dearáí ar líne.

Lean an Oifig freisin le feasacht a chur chun cinn ar MI i meas daltaí dara leibhéal, tuismitheoirí agus baill den phobal ag freastal ar Thaispeántas Eolaithe Óga agus Teicneolaíochta BT. Thug Comórtas an Aireagóra Sóisearach, a cuireadh ar siúl i gcomhar le Lá Domhanda MI san Aibreán, deis freisin le haireagán agus nuálaíocht a chur chun cinn i mbunscoileanna ar fud na tíre.

Taispeántas Eolaithe Óga agus Teicneolaíochta BT

Cuireadh Taispeántas bliantúil Eolaithe Óga agus Teicneolaíochta BT ar siúl san RDS, Baile Átha Cliath ón 12 - 14 Eanáir 2011. Le os cionn 500 taispeántóir ann, bhí taispeántas na bliana seo ar cheann de na cinn ba mhó. Tá an taispeántas le fada ina thairseach le spéis a spreagadh in eolaíocht i meánscoileanna agus i mbunscoileanna. Arís bhí seastán ag Oifig na bPaitinní ann do thréimhse an taispeántais. Tá sé faigte amach againn go bhfuil a bheith i láthair ag an taispeántas ina bhealach áisiúil le heolas thabhairt amach ar mhaoin intleachtúil don ghlúin níos óige agus le comhairle a thairiscint do rannpháirtithe i dTaispeántas na nEolaithe Óga ar phaitinní. Lean an Oifig le hurraíocht a dhéanamh ar dhuais speisialta ag imeacht na bliana seo. Bronntar Duais Oifig na bPaitinní Éireannach ar an mac léin ná ar ghrúpa de mhic léinn ar fearr a léiríonn a dtionscadal úsáid na teicneolaíochta i bhfeidhmeanna nua ná feabhsaithe, i bhfeabhsú éifeachtúlachta agus nuálaíochtaí.

Ba é an buaiteoir ar dhuais urraithe Oifig na bPaitinní do 2011 ná Quinn Unger ó Mheánscoil Mount Saint Michael, Ros Ó gCaire, Corcaigh lena thionscadal “Troitheán amháin a chur in ionad dhá thriotheán olldoird - .i. dearadh le triotheán amháin a chur in ionad triotheán olldoird a oibríonn le seafta tiomána le go saorfaí an “hi-hat” chun áisiúlachta an drumadóra”.

Aireagóir Sóisearach 2011

Is í aidhm chomórtais an Aireagóra Shóisearach spreagadh a thabhairt do leanaí le bheith nuálach agus cruthaitheach maidir le réiteach a aimsiú ar fhadhanna laethúla agus spéis san eolafocht agus san innealtóireacht a chothú iontu agus iad óg. Bhí os cionn 2,500 iontráil ó 234 scoil ar fud na hÉireann páirteach i gcomórtas 2011 a tionóladh le ceiliúradh a dhéanamh ar an Lá Domhanda Maoine Intleachtúla ar an 26 Aibreán.

Ba iad buaiteoirí 2011 grúpa de dhaltaí ó rang 6 Andrew Doran, Roisin Connolly, Kate Dowling agus Abbie Byrne ó Scoil Naomh Iosaf, Bealach Conglais, Co. Chill Mhantáin. Ba é teideal a n-iontráil a fuair an bua ná "Fáil ar Shúiochán i bPictiúrlann" do chóras soilsithe do phictiúrlanna a éascaíonn suíochán a aimsiú sa dorchadas. Dúirt an grúpa gurbh é an smaoineamh a bhí acu ná go mbeadh solas bídeach glas le feiceáil ar shúiochán na pictiúrlainne nuair a bheadh sé seasta agus gan é in úsáid. Dá mbeadh suíochán in úsáid nó go mbeadh an té a bhí suite ann imithe go sealadach, bheadh an solas ar an suíochán dearg ar feadh tréimhse deich nóiméad. Tar éis an ama seo d'iompódh sé ar ais ar ghlás le tabhairt le fios go raibh an suíochán ar fáil arís.

Bhronn an tAire Seán Sherlock TD na duaiseanna ag an searmanas bronnta duaise i gCill Chainnigh.

Cuspóir (5)

An fhoireann a aithint mar phríomhshóchmhainn na hOifige agus úsáid a bhaint as pleanál gnó agus bainistítíocht agus forbairt feidhmíochta indibhidiúil le feabhas a chur ar fheidhmíochta agus nósanna imeachta gnó agus feabhas a chur ar éifeachtúlacht eagraíochtúil.

Tá toimantas leanúna ch na foirne, ag gach leibhéal, maidir le seirbhís éifeachtach ar ardchaighdeán a sholáthar, le túis a chur agus soláthar a dhéanamh ar athrú le feabhas a chur ar chleachtais oibre, tar éis a cheadú don Oifig seirbhís éifeachtach ar ardchaighdeán a sholáthar le níos lú acmhainní foirne. Ón 31 Nollaig 2011, bhí an Oifig ag feidhmiú le 57 post údaraithe, laghdú de 2 ar 2010. Déanann foireann Oifig na bPaitinní ionadaíocht ar Éirinn ar Chomhairle Riarachán an EPE agus ar a Coistí éagsúla, ar Bhord Riarachán OCMI agus roinnt dá coistí teicniúla agus idirchaidrimh a bhíonn ag déileáil le ceisteanna éagsúla a bhaineann le maoín intleachtúil. Ina theannta sin, bíonn an fhoireann rannpháirteach i gcuinnithe chomhlachtaí rialaithe agus teicniúla an Eagraíocht Dhombhanda um Maoín Intleachtúil (EDMI) (a riarrann an Conradh Comhoibrithe Paitinne agus socrutithe faoi Phrótacal Mhaidrid ag déileáil le hiarratais ar thrádmharcanna idirnáisiúnta) in éineacht le roinnt chonarthaí idirnáisiúnta MI.

Déanann an EPE agus an OCMI slite eile a thairiscint le cosaint MI a fháil san Eoraip agus tá rannpháirtíocht na hOifige leis na heagraíochtaí seo thírithe ar a chinntíú go mbíonn ionadaíocht iomcuí ag leasa na hÉireann, ar fanacht suas chun dáta le deachleachtas ag leibhéal idirnáisiúnta agus éascú a dhéanamh ar chomhoibriú le hofigí eile maoine tinsclaíoch náisiúnta agus idirnáisiúnta.

Euroclass

Is uirlis ar líne é EUROCLASS a cheadaíonn d'íarratasóirí agus úsáideoirí trádmharcanna féachaint ar liosta earraí agus seirbhísí a bhfuil glacadh leo ag na seacht nOifig déag atá rannphárteach. Ceapadh é le cabhrú le hiarratasóirí ar thrádmharc téarmaí a bheadh inghlactha a ainthint agus a n-éarráí agus a seirbhísí a rangú i gceart sna haicmí cearta. Má bhíonn téarma liostáilte i mbunachar sonraí EUROCLASS na hÉireann glactar leis go bhfuil sé bailí. Nuair nach bhfaightear aon iontráil, is féidir go n-aithneofaí liosta de mhalaир téarmaí inghlactha sna haicmí a guardáodh. Mura bhfuil ann d'iontráil don téarma atá beartaithé i EUROCLASS is féidir go loirgeodh an Oifig soiléiriú ar an larratasóir.

Tá an córas bunaithe ar an 9Ú Eagrán d'Aicmiú Nice faoi bhainistíocht WIPO. Áirítear timpeall 10,000 iontráil i mBéalra i Liosta Aibítreach Aicmiú Níce agus tá bhrefis agus 100,000 iontráil i mBéalra sa bhunachar sonraí comhchuibhithe. Feidhmeoidh an WIPO mar idirghabhálaí i gcás aighnis idir rannpháirtithe.

Déanadh uirlis EUROCLASS a fhorbairt mar thionscadal comhoibrithe leis an OHIM agus oifigí náisiúnta trádmharcanna ó roinnt ballstát an AE. Tá sé á óstáil ar shuíomh gréasáin an OHIM agus is féidir rochtain a fháil freisin air ó na leathanaigh atá ag déileáil le rangú trádmharcanna ar shuíomh gréasáin Oifig na bPaitinní.

TMview - amharcTM

Is tionscadal eile comhoibrithe é amharc TM idir an OHIM, WIPO agus oifigí náisiúnta trádmharcanna. Is uirlis chomhairliúcháin ar líne é á óstáil ag OHIM a thugann deis d'úsáideoirí guardach a dhéanamh, **saor in aisce**, ar thrádmharcanna gach oifig trádmharcanna oifigiúla atá rannphárteach sa tionscadal. Le imeascadh á dhéanamh de réir a chéile ar gach oifig agus eagraíocht, tá sé ar intinn ag amharc TM a bheith mar ardán do shonraí cláraithe trádmharcanna gach ceann de na 27 Ballstát den AE in éineacht leis an eolas atá ar fáil ó OHIM agus WIPO. Thosaigh Oifig na bPaitinní in Éirinn ag plé le OHIM i 2011 d'fhoínn comhtháthú a dhéanamh ar a bunachar sonraí trádmharcanna agus a faisnéis chláráithe in amharcTM.

Bunaithe ar na forálacha seo, is féidir le hiarratasóirí nó úinéirí RTC a bhfuil trádmharc náisiúnta cláraithe roimhe seo atá mar a chéile i gceann de Bhallaistáit an AE d'earraí agus seirbhísí atá mar a chéile, sinsearachta an mharc sin a éileamh. Ceadaíonn seo dóibh na cearta a bhí acu roimhe sin a choimeád fiú má ghéilleann siad a dtrádmharc náisiúnta nó mura ndéanann siad athnuachan air. Leanfaidh an ceart a fuarthas le clárú náisiúnta faoi scáth an RTC.

Braitheann forfheidhmiú éifeachtach na n-éileamh sinsearachta ar shonraí iontaofa a bheith ann agus iad coimeádta i mbunachair sonraí agus i gcláir na n-oifigí náisiúnta ábhartha, atá, dá réir sin, ar cheann de na príomhfhaoinsí eolais a fhaigheann

an úsáideoir deiridh. I rith 2011, chríochnaigh an Oifig tionscadal comhoibrithe leis an OHIM mar a ndearna an Oifig uasghrádú ar ábhar a cláir trádmharcanna d'fheann cásanna mar a mbíonn an OHIM tar éis an Oifig a chur ar an eolas maidir le héileamh sinseachta maidir le clárú trádmharc náisiúnta Éireannach a chur in iúl. Is féidir freisin nasc a dhéanamh siar ón gclárú Éireannach chuig an iontráil ar an gclár iomchú RTC ar líne trí chliceáil ar mhionsonraí uimhir an RTC ar a bhfuil éileamh sinseachta an mharc náisiúnta á dhéanamh.

Fógraíodh ag Comhdháil Faisnéise Paitinne EPO in Éirinn i nDeireadh Fómhair 2011, go bhfuil an EPO i gcomhar leis na hoifigí paitinne náisiúnta tar éis tosú ar chlár le domhain-nascadh a dhéanamh ar shonraí ar chláir phaitinne náisiúnta a éascaíonn rochtain ar fhaisnéis ar stádas dlíthiúil phaitinní Eorpacha. Ceadaíonn scrúdú ar líne ar Chlár Phaitinní Eorpacha an EPO rochtain anois ar an taifead náisiúnta atá i gClár Paitinní na hÉireann agus roinnt chlár paitinní náisiúnta tríd an domhain-nasc iomchú. Tá an EPO ag obair ar líon na gclár náisiúnta ar féidir domhain-nasc a dhéanamh leo ar an mbealach seo a mhéadú.

EUROTAB

Toisc go bhfuil Éire páirteach sa Choinbhinsiún Eorpach ar Phaitinní (CEP) tá cuid mhór i bpáirt aici leis an 37 comhbhall maidir le cleachtas paitinne. Tá ar gach ballstát prionsabail dlí paitinne na hEorpa a bheith le feiceáil ina reachtaócht náisiúnta féin. Mar sin féin, laistigh de gach dlínse, is féidir éagsúlacht a bheith ar bhéim agus léirmhíniú de réir chleachtais agus traidisiún náisiúnta. Is cruinniú bliantúil comhstádais é EUROTAB mar ar féidir le scrúdaitheoirí paitinne ó bhallstáit CEP agus Oifig Phaitinne na hEorpa (OPE) teacht le chéile agus plé a dhéanamh ar cheisteanna comhleasa nó ar dhibhéisreacht i gcleachtas náisiúnta.

I mbEaltaine 2011, rinne Oifig Phaitinne agus Trádmharcanna na Gearmáine (DPMA) óstáil ar an gcurinniú seo ag a ceannáras i Munchen. Chuir Éire páipéar tosaigh i láthair ar cheann de phríomh-mhíreanna an chláir oibre, is é sin “Deimhniú Cosanta Forlíontach: forfheidhmiú agus cleachtas náisiúnta”. Ar na ceisteanna eile a pléadh ag an gcurinniú bhí:

- Paitinní dúbailte;
- Cuardaigh staid na teicneolaíochta Áiseacha;
- Idirghníomhaíocht idir Oifig Paitinne agus iarrtasóirí/ionadaithe: taithí ar fhorbairt agus úsáid choinchéapa deachleachtais.

Comhdháil faoin bhFaisnéise Paitinne 2011

I mí Dheireadh Fómhair rinne Oifig na bPaitinní óstáil ar Chomhdháil faoin bhFaisnéis Paitinne OPE 2011 i gCill Chainnigh in Óstán agus Ionad Comhdhála Lyrath ar imeall na cathrach. Tá an comhdháil, a eagraíonn Oifig Phaitinní na hEorpa, ar siúl ó 1991 agus tá sé tar éis fás go dtí go bhfuil sé ar cheann de na himeachtaí is mó dá leithéid i ndomhan na Moine Intleachtúla. Tháinig 320 toscaire ann i mbliana – cuardaitheoirí paitinne, saineolaithe faisnéise agus soláthróirí gairmiúla sonraí agus seirbhísí cuardaigh – ó chomh fada i gcéin leis an tSín, an Astráil agus an Nua-Shéalaínn. Tagann mórán de na saineolaithe seo ó chuid de na cuideachtaí is nuálaí ar an ardán domhanda, mar Nokia, Siemens, Shell agus Novartis.

Ba é an tAire Richard Bruton a d'oscail an chomhdháil agus chuir sé béim ar an tábhacht sa bhereis atá le nuálaíocht agus maoin intleachtúil i ngeilleagar na hÉireann. Ina aitheasc tosaigh dúirt Uachtaráin an EPO Benoît Battistelli, “go deimhin is ceart ag an bpobal é rochtain a bheith acu ar fhaisnéis phaitinne, rud a leagann dualgas orainn sonraí na bpaitinní a fhoilsíú leis an bhfollasacht is mó”. Ar an mbealach seo chuir sé béim ar an tábhacht atá le rochtain ar shonraí na bpaitinní ar fud an domhain, agus rinne sé comparáid le tionscnaimh “rialtais oscailte” le déanaí i SAM agus san Eoraip.

Ag díriú dó ar an téama “sonraí oscailte” chuir duine de an príomhchainteoirí, an tOllamh Nigel Shadbolt, ó Ollscoil Southampton agus comhairleoir ag Rialtais an RA, béim ar na deiseanna atá ar fáil do chuideachtaí mórán dá sonraí rialtais atá dímhaoin a phróiseáil go feidhm úsáideach gréasáin agus taistil chun leasa na saoránach agus na bpobal. Thug sé dúshlán freisin do gach oifig phaitinne a bhfoinsí luachmhara sonraí a bheith chomh hoscaithe agus i bhfoirm chomh inrochtana agus is féidir é.

Labhair Jim O’Hara, a chuaigh ar scor le déanaí mar POF ar Intel Ireland agus mar a bhí i ndiaidh Chathaoirleach ar Thascfhórsa an Rialtais ar Bheartú Tosaíochta Taighde, ar an ábhar “Dearcadh ardteicneolaíochta ar phaitinní agus a dtionchar ar fhorbairt gnó”.

In éineacht leis na láithreoirreachtaí foirmeálta comhdhála, bhí sraith de phléighrúpaí beaga ann freisin ar cheisteanna éagsúla a bhain le hábhar mar chruthú agus chothabháil bhunachar sonraí stádais dlíthiúil domhanda, feabhsú ar sheirbhísí aistriúcháin uathoibríoch ar dhoiciméid phaitinne, agus an tábhacht atá le caighdeán aontaithe a fhorbairt do bhunachair sonraí phaitinne. Bhí an taispeántas ar siúl ag an am gcéanna leis na himeachtaí a bhí ar an gclár ama, le 30 seastán ag na cuideachtaí móra faisnéise i réimse MI, mar Thomson Reuters, Questel agus Dialog.


